FALL RIVER COUNTY MINUTES OF JANUARY 3, 2013

The Fall River Board of County Commissioners met in regular session on January 3, 2013. Present: Michael Ortner, Deb Russell, Joe Allen, Anne Cassens, Joe Falkenburg, and Sue Ganje, Auditor. Absent: none.

Ortner, Allen and Cassens gave the Oath of Office and were sworn in by the Honorable Judge Jeff Davis.

The Pledge of Allegiance was given and the meeting called to order at 9:00 AM.

The agenda was reviewed for conflicts; none were noted. Motion by Russell, seconded by Cassens, to approve the agenda as written. With no further discussion and all voting yes, the motion carried.

Motion by Falkenburg, seconded by Cassens, to nominate Ortner as Chairman for 2013. A call for further nominations resulted in no additional nominations. With no further discussion, Ortner abstaining and all others voting yes, the motion carried.

Motion by Russell, seconded by Allen, to nominate Falkenburg as Vice-Chairman for 2013. A call for further nominations resulted in no additional nominations. With no further discussion, Falkenburg abstaining and all others voting yes, the motion carried.

Motion by Falkenburg, seconded by Russell, to set the Hot Springs Star and Edgemont Herald Tribune as the official newspapers for the County for 2013. With no further discussion, Cassens abstaining and all others voting yes, the motion carried.

Motion by Falkenburg, seconded by Cassens, to designate three feet of the bulletin board in the Courthouse lobby for legal matters and to post Commission agendas on the ground and first floor doors of the courthouse. With no further discussion and all voting yes, the motion carried.

Motion by Cassens, seconded by Falkenburg, to designate the following as locations for Chattel Mortgage Sales: Hot Springs, front door of the Courthouse; Oral, front door of the Post Office; Oelrichs, front door of the Post Office; Edgemont, front door of the Post Office. With no further discussion and all voting yes, the motion carried.

Motion by Falkenburg, seconded by Russell, to designate Bank of the West, Wells Fargo Bank, First Interstate Bank and Black Hills Federal Credit Union as the official banks for Fall River County for 2013, with First Interstate Bank as the active account. With no further discussion and all voting yes, the motion carried.

Discussion was held on burial fees. Motion by Russell, seconded by Falkenburg, to set burial fees at \$1,700.00 total cost, \$1,200.00 for individuals one year old or younger and \$1,300.00 for cremation; an additional \$400.00 if a vault is required; mileage paid at \$1.00 per loaded mile to the Black Hills National Cemetery. After some discussion on whether vaults were required by all area cemeteries, Russell amended her motion to remove the \$400.00 allotment for a vault, which Falkenburg seconded. With no further discussion and all voting yes, the amended motion carried.

Sheriff Mraz was present for a discussion on setting the cost of prisoner care, informing the Board that Pennington County's rate is \$69.00 per day. Motion by Falkenburg, seconded by Russell, to set the 2013 cost of prisoner care at \$69.00 per day and work release at \$22.00 to \$34.39 per day at the discretion of the Sheriff. With no further discussion and all voting yes, the motion carried.

Motion by Cassens, seconded by Falkenburg, to name Black Hills Family Health Clinic as the primary caregiver and Fall River Health Services as the secondary caregiver for 2013. With no further discussion and all voting yes, the motion carried.

Motion by Falkenburg, seconded by Cassens, to establish the following Commissioner

appointments for 2013: Falkenburg as the representative to the Fall River 4H Advisory Board, Russell as the alternate; Allen as the representative to the L.E.P.C. Board, Russell as the alternate; Falkenburg as the representative to the Fall River County Weed Board, Allen as the alternate; Cassens as the representative to the Custer / Fall River Regional Waste Management Board, Russell as the alternate; Russell as the representative to the 6th District Board of the Black Hills Council of Local Government, Cassens as the alternate; Ortner as the representative to the Juvenile Detention Board, Allen as the alternate; and Ray Palmer as the representative on the RC&D Board. With no further discussion and all voting yes, the motion carried.

Motion by Russell, seconded by Cassens, to approve travel of the county officials to attend meetings of the Black Hills Associations and to request office supervisors obtain travel approval for all other meetings. With no further discussion and all voting yes, the motion carried.

Motion by Falkenburg, seconded by Russell, to approve the following Resolution. With no further discussion and all voting yes, the motion carried.
