Motion by Falkenburg, seconded by Abbott to take the lowest quote to get the tree removed prior to damage. With no further discussion and all voting yes, the motion carried.

Frank Maynard, Emergency Management, updated the Board regarding Homeland Security grants; requested purchase of a laptop, and presented a quote. Motion by Falkenburg, seconded by Abbott, to approve the laptop purchase in the amount of \$799.00. With no further discussion and all voting yes, the motion carried.

Jim Sword requested travel approval for Edie Jenniges. Motion by Falkenburg, seconded by Abbott, to approve travel for Edie Jenniges to attend the Sexual Violence Institute in Sioux Falls, from December 2-4, 2015 at a cost of \$148.74. With no further discussion and all voting yes, the motion carried.
