The Fall River Board of County Commissioners met in regular session on November 20, 2014. Present: Joe Falkenburg, Mike Ortner, Deb Russell, and Sue Ganje, Auditor. Absent: Anne Cassens and Joe Allen.

The Pledge of Allegiance was given and the meeting called to order at 9:00 AM.

The agenda was reviewed for conflicts; none were noted. Motion by Falkenburg, seconded by Russell, to approve the agenda as written. With no further discussion and all voting yes, the motion carried.

Motion by Russell, seconded by Falkenburg, to approve the minutes of the November 6, 2014 meeting. With no further discussion and all voting yes, the motion carried.

Motion by Falkenburg, seconded by Russell, to advertise for letters of interest regarding a vacancy on the Fall River Housing and Redevelopment Board, setting Dec. 18, 2014 at 9:50 AM as the time to open submissions. With no further discussion and all voting yes, the motion carried.

Motion by Russell, seconded by Falkenburg, to approve and place on file the September, 2014 General Fund Surplus Analysis as follows. With no further discussion and all voting yes, the motion carried.

# FALL RIVER COUNTY GENERAL FUND SURPLUS ANALYSIS DATE: SEPTEMBER 30, 2014

The amount of General Fund dollars that counties can retain as surplus is restricted by SDCL 7-21-18.1, which states: "The total unreserved, undesignated fund balance of the general fund may not exceed forty percent of the total amount of all general fund appropriations contained in the budget for the next fiscal year. The total unreserved, undesignated fund balance of the general fund of the county as of March thirty-first and September thirtieth shall be published in the minutes of the proceedings of the board of county commissioners and reported to the Department of Legislative Audit. The report shall be on forms prescribed by the Department of Legislative Audit."

The following analysis should be completed as of March thirty-first and September thirtieth of each year. Thereafter, the unreserved, undesignated fund balance amount should be published in the minutes of the governing board. This analysis should also be filed with the Department of Legislative Audit.

Frank Maynard, Emergency Management, presented an estimate for the Board's review. Motion by Russell, seconded by Falkenburg, to approve approximately \$1,500.00 for the purchase of a new light bar for the new EM pick up. With no further discussion and all voting yes, the motion carried.

Maynard updated the Board on the PDM, bridges being replaced by the BNSF Railroad and reported on a workshop conducted by Safety Benefits. Bids submitted for the truck formerly used for the repeater on Ball Ranch were reviewed, which were \$10.00 from Richard Ball and \$108.00 from Gary Dinkel. Motion by Falkenburg, seconded by Russell to approve the \$108.00 bid from Gary Dinkel as the high bid for the Ball Ranch repeater truck. With no further discussion and all voting yes, the motion carried.

Department supervisors met with the Board to consider closing the courthouse on Friday, Dec. 26, 2014 as city and state offices will be closed, which will limit services available to patrons. Ortner and Falkenburg stated the Board doesn't have authority to grant additional holidays, per the Union contract.

Treasurer Kelli Rhoe presented a quote for pre-sorting and mailing the 2015 tax notices, which will save \$496.00 in postage costs and the staff time associated with preparing the mailing. Motion by Falkenburg, seconded by Russell, to approve \$5,758.00 to out-source mailing the 2015 tax notices. With no further discussion and all voting yes, the motion carried.

Rhoe sought approval for staff changes. Motion by Russell, seconded by Falkenburg, to approve reclassifying Peggy Burg to part-time and Denise Warford to full-time, both effective Nov. 17, 2014. With no further discussion and all voting yes, the motion carried.

Lyle Jensen, Building Superintendent, presented a quote for rock removal. Motion by Falkenburg, seconded by Russell, to approve \$600.00 for Rod Reynolds to remove rock from the

bluff along the north parking lot. With no further discussion and all voting yes, the motion carried.

Jensen reported that David Lund has begun working through the Experience Works program.

Randy Seiler, Highway Superintendent, asked the Board to surplus equipment. Motion by Falkenburg, seconded by Russell, to surplus a 2009 140M motorgrader, serial #PB9M00810, and advertise it for sale, including in the Machinery Trader. With no further discussion and all voting yes, the motion carried.

Choosing appraisers for the motorgrader was discussed; Seiler stated some counties have the commissioners appraise items. Motion by Russell, seconded by Ortner, to set 10:10 on Jan. 15, 2015 as the time to open bids on the motorgrader and to appoint Tom Conger, Steve Simunek and Falkenburg as the appraisers. With no further discussion and all voting yes, the motion carried.

Discussion was held on weekend snow removal and the related matters of the difficulty in knowing which roads are blocked, wind drifting and providing safe, timely access for travel to schools. All agreed on the need for better communication of roads needing attention and Seiler obtaining approval from commissioners for overtime work for future incidents and agreed to continue to work with schools.

Motion by Falkenburg, seconded by Russell, to approve the bills as follows. With no further discussion and all voting yes, the motion carried.
