FALL RIVER COUNTY MINUTES OF JUNE 20, 2013

The Fall River Board of County Commissioners met in regular session on June 20, 2013. Present: Mike Ortner, Joe Falkenburg, Anne Cassens, Deb Russell and Sue Ganje, Auditor. Absent: Joe Allen.

An invocation and the Pledge of Allegiance were given. The meeting called to order at 9:00 AM.

The agenda was reviewed for conflicts; none were noted.

Motion by Russell, seconded by Falkenburg, to approve the agenda as written. With no further discussion and all voting yes, the motion carried.

Motion by Falkenburg, seconded by Russell, to approve the minutes of June 6, 2013 with a correction to reflect that Cassens made the motion to adjourn into Executive Session at 11:40 AM, not Ortner as written. With no further discussion and all voting yes, the motion carried.

Motion by Russell, seconded by Falkenburg, to approve the Auditor's Account with the Treasurer as follows. With no further discussion and all voting yes, the motion carried.

The above balance reflects county monies, monies held in trust and monies collected for and to be remitted to other ENTITIES: SCHOOLS, TOWNS, TOWNSHIPS, FIRE & AMBULANCE DISTRICTS AND STATE.

An assistance application submitted by McColley's was reviewed. Motion by Russell, seconded by Falkenburg, to take no action on application CP #2013-18 for cremation assistance. With no further discussion and all voting yes, the motion carried.

Discussion was held on an alternative meeting location for the August 1, 2013 meeting as a jury trial is currently scheduled and the jury room may be needed. If the trial is held, the meeting will move to the ground floor meeting room.

Ortner shared with the Board a proclamation he will be reading at a ceremony on July 1, 2013, which will honor C-130 crewmembers who were killed or injured while fighting the White Draw fire. Motion by Cassens, seconded by Falkenburg, to approve the proclamation. With no further discussion and all voting yes, the motion carried.

The Auditor advised the Board that the County received \$631,192.00 in PILT funds, which is approximately \$1,500.00 less than in 2012.

The Board reviewed an Institutional Analysis Interview questionnaire received from Parsons Company in reference to the U.S. Army Corps of Engineers' Remedial Investigation and Feasibility Study for the Black Hills Army Depot. Frank Maynard, Emergency Management, advised the Board he has questions about the project and shared an email he received from Brian Daunt, Forest Service, which states that he was informed that the project at Igloo is done. Motion by Falkenburg, seconded by Russell, to authorize Ortner and Maynard to draft a letter opposing the completion of the project until further information is provided. With no further discussion and all voting yes, the motion carried.

A Joint Powers agreement was presented. Motion by Falkenburg, seconded by Russell, to approve a Joint Powers agreement with the State of South Dakota, Dept. of Agriculture, Wildland Fire Division that will allow for assistance on wildland fires and risk incidents, authorizing the Chairman to sign. With no further discussion and all voting yes, the motion carried.

Maynard updated the Board on boiler maintenance, the courthouse phone system, and presented a request for use of the command trailer. Motion by Falkenburg, seconded by Russell, to authorize the Hot Springs Radio Club's use of the command trailer for their annual field day exercise. With no further discussion and all voting yes, the motion carried.

Discussion was held on reassignment of some county vehicles. Motion by Russell,

seconded by Falkenburg, to reassign from the Sheriff's Office a 2006 Durango to Emergency Management and a 2007 Durango to courthouse employee use. With no further discussion and all voting yes, the motion carried.

Susan Henderson met with the Board to discuss a letter Governor Daugaard sent on February 22, 2012 to the US Dept. of Energy in support of funding for the South Dakota School of Mines and Technology to research shale formations and her concerns that it could lead to a nuclear waste site in the county. Motion by Falkenburg, seconded by Russell, to state they do not object to the shale study but oppose any potential nuclear waste site in Fall River County. With no further discussion and all voting yes on a roll-call vote, the motion carried.

The meeting opened for public comment. Bob Nelson and Don Ackerman updated the Board on plans for the "Honoring Our Heroes" event in Hot Springs on July 31 through August 4, 2013. Commemorative coins were presented to the Board in appreciation of support. Ackerman reviewed activities and discussed needs for which the County may be able to provide assistance. The Board expressed appreciation for all Nelson and Ackerman have done for the event.

Randy Seiler, Highway Superintendent, met with the Board to discuss personnel. Motion by Falkenburg, seconded by Russell, to approve appointing Bruce McClung as Foreman, increase of wage to \$17.89, as per Union Contract. With no further discussion and all voting yes, the motion carried.

Seiler reported that State Game, Fish and Parks has agreed to contribute 40% of the cost of applying mag water to Sheps Canyon Road, not 60% as provided in 2012, which was an exception. Seiler also reported that on Angostura Road, they will contribute 70-75% of the cost of chip sealing in 2014, which would cost \$40,000.00 for the county's share. As chip sealing costs have increased, Seiler suggest the county give specific consideration to such projects when completing the road tour. Motion by Falkenburg, seconded by Russell, to approve the agreement to apply mag water to Sheps Canyon Road with the State Game, Fish and Parks department providing 40% of the cost and the county the remainder. With no further discussion and all voting yes, the motion carried.

Motion by Falkenburg, seconded by Russell, to approve the bills as follows. With no further discussion and all voting yes, the motion carried.

Susie Hayes, Director of Equalization, met to present information on a discussion with Bill Cox regarding the tax status of his property and whether a property used for benevolent purposes is exempt. A phone conference call was held with Mr. Cox, with Ortner abstaining from conversation.

Gravel bids were opened at 10:25 AM as advertised. Motion by Falkenburg, seconded by Russell, to accept Western Construction's bid of \$3.06 per ton as the low bid. With no further discussion and all voting yes, the motion carried.

Cindy Brunson asked the Board for an update on the Igloo Bridge and discussed leaks in the Provo Water System. The Board asked her to talk to Seiler about roads in Igloo so he could bring recommendations to a future meeting. Brunson also asked the Board's position on fracking done on BLM land; Falkenburg asked her to bring information to the Board as he would oppose any fracking operation.

A hearing on temporary Malt Beverage licenses was held as advertised. Motion by Cassens, seconded by Russell, to approve the temporary Malt Beverage license applications made by the Victory Steakhouse and the Hat Creek Grill for the Edgemont Redneck Rally. With no further discussion and all voting yes, the motion carried.

Sharon Moad, Crazy Horse Civil Air Patrol, met to update the Board on their progress and services, asking for \$850.00 in funding of the current year. Ortner informed her funds for 2013 are already allocated but that the Board would consider an application for 2014.

Carl Shaw, Edgemont City Mayor, was present for a discussion on a county-owned property located at 511 7th Street in Edgemont. The building is in need of demolition, which is

estimated to cost \$7,140.00. Shaw stated that the City is not interested in taking ownership by deed. Discussion was held on whether the demolition or rubble costs could be reduced; Cassens said she would see if a reduced rate at the Custer / Fall River Landfill could be arranged. Motion by Cassens, seconded by Falkenburg, to approve the county providing half the cost of demolishing the structure at 511 7th Street in Edgemont and to aid in reducing costs as possible. With no further discussion and all voting yes, the motion carried.

Jim Sword, State's Attorney, asked the Board to reclassify staff. Motion by Falkenburg, seconded by Russell, to approve reclassifying Shari Winslow as an administrative assistant at a rate of \$10.83 per hour, per Union contract. With no further discussion and all voting yes, the motion carried.

Hayes returned to the Board to discuss setting a policy to address requests for data. She, along with Register of Deeds Mel Engebretson and Stacey Martin, GIS, will work up a policy with Sword and bring it back to the Board at a future meeting.

An applicant for assistance met with the Board. Motion by Falkenburg, seconded by Russell, to approve \$229.00 for a water heater for CP #2013-19, with a repayment plan that includes a prior balance. With no further discussion and all voting yes, the motion carried.

The Board recessed for lunch at 11:49 AM. The Board reconvened at 1:30 PM. Motion by Cassens, seconded by Russell, to enter into Executive Session for personnel interviews, per SDCL-1-25-2(1). With no further discussion and all voting yes, the motion carried and the Board went into Executive Session at 1:31 PM.

The Board came out of Executive Session at 2:42 PM. Motion by Cassens, seconded by Falkenburg, to offer the position of Maintenance Supervisor to Lyle Jensen with a start date of June 24, 2013, at a salary of \$30,000 with an increase of \$2,000.00 at the end of a satisfactory six-month probation period. With no further discussion and all voting yes, the motion carried.

Motion by Cassens, seconded by Russell, to adjourn. With no further discussion and all voting yes, the motion carried and the meeting adjourned at 2:47 PM.
