

ATV Grasshopper Sprayer Demonstration

Friday, April 27, 2:00 PM -Hot Springs, Courthouse Parking Lot behind Weed and Pest office



APHIS will be here to demonstrate and explain the benefits of using this modified ULV spraver that is mountable on an ATV for control of grasshoppers. With this sprayer and the RAATS setup we can treat 4 times more acres than with a standard sprayer. FRC W/P staff will explain the importance of calibrating herbicide sprayers. If you would like to have your own sprayer calibrated that day, call the office and make an appointment and we will check your machine.

(ATV or UTV units only.)

KEEP A RECORD

Private pesticide applicators must record their restricted use pesticide applications. Keeping records on all pesticide use will also help you:

- Evaluate how well a chemical worked. •
- Figure how much pesticide you will need in a future year.
- Prevent carry-over injury •
- Protect you from legal action if you are accused of improper pesticide use. Record books are available at the Weed and Pest Office or on-line at http://www.ams.usda.gov/AMSv1.0/getfile?dDocN ame=STELPRD3342981

Pesticide Container Recycling Collection... How To Participate:

Eligibility: Farmers, ranchers, homeowners, and others using pesticides. What can be Recycled: empty and properly rinsed rigid plastic pesticide and surfactant containers of any size.

Preparation of containers: It is the responsibility of the applicator to properly prepare the containers for recycling.

Rinsing: Eligible pesticide containers must be, at a minimum, triple rinsed or pressure rinsed IMMEDIATELY after empting them. **Caps:** It is requested, but not mandatory, that caps be removed. Labels: it is requested, but not mandatory, that labels be removed. **Collection Area:** Designated containment area in the Fall River County Weed and Pest Shop Yard, on Rathbun Rd, behind the County Highway Shop on Hwy 71.

The County Weed and Pest Staff will haul collected containers to the State Collection site in the Fall. For more information on pesticide container recycle visit www.sdda.sd.gov/Ag services/

Three "Hot" Weeds You Have Been Asking About **Puncture Vine** Locoweed/Crazyweed **Curleycup Gumweed** 1 Quart/per acre of Platoon 1 Quart /per acre of Platoon 2 Quarts/per Acre of <u>Weedmaster</u> (2,4-D Amine)(Dicamba / 2,4-D) (2,4-D Amine)Plus a 90% non-ionic surfactant $\frac{1}{2}$ oz./per Acre of Metzel <u>or</u> Plus a 90% non-ionic surfactant 1 oz / per acre of Escort Apply when new seedings appear. Plus a 90% non-ionic surfactant New seedlings may emerge after application which will mean more Apply before mid-June than one application. ***Always read the labels. Be sure crop use and application directions and rate are followed for the product being used. The above management suggestions come from SDSU and Crop Protection Services.
