The Fall River Board of County Commissioners met in regular session on November 15, 2012. Present: Mike Ortner, Joe Falkenburg, Anne Cassens, Joe Allen and Sue Ganje, Auditor. Absent: Deb Russell.

The Pledge of Allegiance was given and the meeting called to order at 9:00 AM. The agenda was reviewed for conflicts; none were indicated.

Motion by Falkenburg, seconded by Cassens, to approve the agenda as written. With no further discussion and all voting yes, the motion carried.

DISTRICTS AND STATE.

An applicant for assistance met with the Board. Motion by Cassens, seconded by Allen, to approve \$300.00 in rent assistance for CP #2012-34 with a repayment plan. With no further discussion and all voting yes, the motion carried.

Motion by Cassens, seconded by Allen, to approve the one-year raise for Coreen Williams to \$10.00 per hour per Union contract, effective October 30, 2012. With no further discussion and all voting yes, the motion carried.

The Homeland Security Grant was presented for approval. Motion by Falkenburg, seconded by Allen, to approve the Homeland Security Grant for 2013 in the amount of \$70,800.00 and authorize the chairman to sign. With no further discussion and all voting yes, the motion carried.

Discussion was held on an application by PowerTech for water rights in the Indian Cara and Madison aquifers. Consideration was given to intervening in the process that would grant them the rights. Jerri Baker, Gary Friendshuh, Dayton Hyde, Susan Watt, Edgemont Mayor Jim Turner and Susan Stolarcek all voiced concerns regarding the protection of water resources, should the water rights be granted. Keith Andersen noted that several people in the area utilize artesian wells, which are not protected by state law. Susan Henderson noted that the deadline to notify the state of intent to intervene is November 26, 2012, adding that as PowerTech has no assets, suing for any incurred damages would be fruitless and she believes PowerTech to be free from any oversight in their actions. Ortner stated that the county has no legal power in the matter as water rights are owned by the state and controlled by the NRC and State Water Board. Falkenburg suggested continuing the matter for discussion at a special meeting at 9:00 AM on the November 26, 2012.

Keith Andersen, Andersen Engineering, presented a plat for approval. Motion by Cassens, seconded by Allen, to approve the following plat of Farm Unit #20-C, contingent upon Highway Superintendent Randy Seiler's signature. With no further discussion and all voting yes, the motion carried.

Lori Bachand, Treasurer, presented a delinquent tax agreement for approval. Motion by Falkenburg, seconded by Allen, to approve a delinquent tax agreement with Larry Job for parcels 721000030000400, 721000030000500, 722200080001700, 722200080000600, 721000030001100 and 722200080000300 in the amount of \$300.00 per month, and authorize the Chairman to sign. With no further discussion and all voting yes, the motion carried. Job will also be requesting a tax moratorium for historical preservation designation, which he will discuss with the Dept. of Equalization and bring back to the Board at a later date.

Donna Talley, Executive Director, and Julie Ann Gramkow, Board President of WEAVE, met with the Board to discuss the 2012 allotment from the county. Concern was expressed by Ortner and State's Attorney Jim Sword that currently there is no Fall River representation on their board or local advocates. Talley indicated that they advertised both positions but had no applications. Sword also indicated he has not seen a WEAVE representative in court lately. Ortner suggested as 2012 funds have been designated for WEAVE, they should receive the remainder of their allotment and further information could be obtained to aid in making a determination on 2013 funding. Motion by Cassens, seconded by Falkenburg, to approve the remaining 2012 funds be allotted to WEAVE and to discuss 2013 funds at a later date. With no further discussion and all voting yes, the motion carried.

Mike Jones, Vision Care Direct, met with the Board to present a Vision Care Direct employee vision plan, which is supported by Dr. Wilkerson, a local provider. The plan will be referred to the employees and brought back to the Board if there is interest.

Randy Seiler, Highway Superintendent, presented fuel bids for approval.

With no further discussion and all voting yes on a roll call vote, the motion carried.

Brad Keizer, 4H/Youth Adviser, Mary Roduner, SDSU Extension Consumer Horticulture Field Specialist, Leacey E. Brown, SDSU Extension Gerontology Field Specialist, and Mindy Hubert, SDSU Extension Small Acreage Field Specialist, met with the Board to discuss services available to the county. Falkenburg commended Keizer for his work as the local adviser.

Motion by Falkenburg, seconded by Allen, to enter in Executive Session for legal matters with Bachand and Stacey Martin, GIS. With no further discussion and all voting yes, the motion carried and the Board went into Executive Session at 10:54 AM.

The Board came out of Executive Session at 10:58 AM and adjourned to the courtroom for the sale of county owned property.

The sale adjourned at 11:32 AM and the meeting resumed with Martin providing answers to questions from Board members on the GIS Connect, which would link the county GIS map system to the county website. Motion by Cassens, seconded by Falkenburg, to approve the corrected GIS Connect Agreement with a review at six months and authorize the chairman to sign. With no further discussion and all voting yes, the motion carried.

Motion by Falkenburg, seconded by Allen, to hold a special meeting on November 26, 2012 at 9:00 AM in the courtroom to continue discussion on PowerTech's water application. With no further discussion and all voting yes, the motion carried.

Motion by Falkenburg, seconded by Cassens to enter in Executive Session for legal and personnel matters. With no further discussion and all voting yes, the motion carried and the Board went into Executive Session at 11:56 AM.

The Board came out of Executive Session at 12:12 PM. Motion by Cassens, seconded by Falkenburg, to adjourn. With no further discussion and all voting yes, the motion carried and the Board adjourned at 12:13 PM.
