- 1) Within ten (10) business days following the Notice of adverse action, the applicant must notify the County Auditor in writing of his/her request for an appeal;
- 2) Within five (5) calendar days following the request for an appeal, the County Auditor shall set a time and place for the appeal hearing. The time and place shall be during the next regularly scheduled board meeting or a special meeting within the ten (10) business days;
- 3) The Auditor shall notify the individual in writing of the time and place of the hearing and the individual's right to personally appear before the Board, to call witnesses, to present information, and to be represented;
- 4) The board shall consider the appeal de novo, taking into consideration any information that may be presented at the time of the appeal. The Auditor shall keep a record of the hearing; and
- 5) Within five (5) calendar days following the hearing, the board shall render a decision based on the facts presented at the hearing and shall provide the person with a written notice of its decision. If the hearing does not provide the relief desired or requested by the person, the notice shall contain information indicating that he/she may seek relief as provided in SDCL 28-13-40.

FALL RIVER COUNTY MINUTES OF MAY 2, 2017

The Fall River Board of County Commissioners met in regular session on May 2, 2017. Present: Ann Abbott, Joe Allen, Joe Falkenburg, Paul Nabholz, Deb Russell and Sue Ganje, Auditor. Absent none.

The Pledge of Allegiance was given and the meeting called to order at 9:00 AM.

The agenda was reviewed for conflicts; none were noted. ALL MOTIONS RECORDED IN THESE MINUTES WERE BY UNANIMOUS VOTE, UNLESS OTHERWISE STATED.

Motion made by Russell, seconded by Abbott, to approve the agenda as written.

Motion made by Nabholz, seconded by Russell, to approve the minutes of April 18, 2017.

Motion made by Nabholz, seconded by Russell, to table the April 11 and April 18, 2017 equalization minutes.

Motion made by Russell, seconded by Abbott to deny the county burial, 2017-05, as assets were available to sell which could reimburse burial costs.

Motion made by Nabholz, seconded by Abbott to surplus to junk items from the Register of Deeds and Auditor's Offices, list on file in the Auditor's office.

Motion made by Russell, seconded by Abbott to set the 2017-2018 Malt Beverage License hearing for renewals on May 16 at 10:50 a.m.

Dustin Ross, Andersen Engineers, presented a plat. Motion made by Abbott, seconded by Allen to approve the plat for Lot 43 and 44, Cobblestone Mt. Estates.

FALL RIVER COUNTY RESOLUTION #2017-14

Kelli Rhoe, Treasurer, met to present an agreement for consideration. Motion made by Allen, seconded by Russell to approve the delinquent tax agreement plan for Linda Valandra, parcel number 75410-01500-0070, \$100 per month. Nabholz questioned if the plan was really needed. With Nabholz voting no, all others voting yes, motion carried.

Rhoe also stated that Joyce Farrell's last day was to be May 3rd with a retirement party from 1 p.m. to 4 p.m. Rhoe also stated that Anna Maciejewski had started on May 1st. Rhoe needed additional hire approval to replace another employee who is leaving. Motion made by Abbott, seconded by Nabholz, to hire Nikki Shaw at \$10 per hour, with a start date of May 15, 2017, as per union contract.

Lyle Jensen, Building Supervisor, stated that Fall River County will have a 911 upgrade in June of 2017. Jensen spoke of a project management workshop in Rapid City. Motion made by Russell, seconded by Abbott, to approve Jensen to attend the Project Management Workshop in Rapid City, 6-9-17, for \$199.

Jensen also spoke of need for a cross walk sign. Motion made by Allen, seconded by Nabholz to authorize Jensen to order a cross walk sign.

Joe Allen stated that Jensen and Frank Maynard's information was invaluable during the security assessment. There will be recommendations in two weeks, and the deadline for the statewide security grant is June 1, 2017.

Frank Maynard, Emergency Management, met with the board. It would cost \$1,368.90 to deliver gravel to the parking lot. There will be no leveling or spreading of the gravel in that cost, but would have a 4" base. Maynard and Jensen will do some more research and bring back.

Maynard advised of a civil disturbance appendix to LEOP; weather spotting – 19 spotters showed; tornado drill – Edgemont Fire department was not receiving texts, the issue is fixed now. There was a structure fire on April 27, 2017.

The public hearing was held for Chops and Hops as advertised. Motion made by Nabholz, seconded by Russell, to approve the name change from Chops and Hops, Inc to Hwy 79 Scratch Kitchen, Inc.

Falkenburg initiated conversation on the need for the US Government to notify the county when they are aware of activities they are involved in that may affect the county. Wes Davidson and Orval Frahm met with the board to give suggestions to update the April 5, 2011 Land Use Policy. Discussion was held on current activities by USFS National Grasslands. It should be made mandatory that Fall River County be notified. Motion made by Allen, seconded by Nabholz to approve revisions to Land Use Policy, with suggested changes.

Nabholz spoke of the Code of the West approved in 2006. Nabholz will bring it to the next meeting with suggested changes.

Charla Reynolds met with the board to request burial assistance for a relative. Reynolds provided \$1,000.00. The county will pay for the rest. Motion made by Russell, seconded by Allen to approve burial assistance for CP 2017-04, with the \$1,000.00 to be considered reimbursement from applicant in full.

Randy Seiler, Highway Department, presented fuel transfers to the board. Motion by Russell, seconded by Abbott, to approve April 2017 fuel transfers to reimburse the highway department for fuel used or work performed as follows: Weed & Pest for \$97.28; Sheriff's Department for \$1,767.72; Emergency Management for \$41.78; and State's Attorney \$55.22.

Motion made by Abbott, seconded by Russell to enter into agreement with Game, Fish and Parks, #2017-27-1, for \$18,000, a cost share on Mag Water for Shep's Canyon Road.

Motion made by Russell, seconded by Nabholz to approve the application for permit to occupy county highway by Golden West from the existing vault along Pilger Mt. Road between Calamity Rd. and Hickock Rd. to the driveway at 11599 Pilger Mt. Road.

A pipeline easement was presented. Motion made by Nabholz, seconded by Russell to approve a pipeline easement for Arnoldy Grain Inc., Michael Arnoldy and Ann M. Arnoldy, easement to be in that area adjacent to the NE Quarter of Section 1 in Township 11S, Range 6E, and the NW Quarter of Section 6 in Township 11S, Range 7E, of the Black Hills Meridian, Fall River County, South Dakota and the pipeline to run from the SE of the NE Quarter of Section 1 in Township 11S, Range 6E, to Lots 4 and 5, Section 6, in Township 11S, Range 7E, of the Black Hills Meridian, Fall River County, South Dakota.

Seiler requested a Gravel Retriever and presented pictures and quotes. Motion made by Allen, seconded by Russell to purchase the Gravel Retriever for \$16,500.

Motion made by Russell, seconded by Abbott, to rescind the previous motion and put on the May 16, 2017 meeting agenda.

Seiler gave the board an update on activities. A short break was taken at 10:00 a.m. and meeting resumed at 10:04 a.m.

Mike McNeill and Kelly Stover, US Forest Service, met with the board to discuss seismic drilling. Falkenburg referred to the Land Use Policy where government entities were to meet and advise the board of current activities. McNeill noted they just got all the information put together to come to the county. McNeill presented a map, noting that all the needed internal comments and concerns have been received. All seismic agreements will include damage to roads to be repaid. Falkenburg asked that notification be made to ranchers so they could know when they are coming and make plans, and noted concerns about the heavy trucks driving over pipelines. Agreements will have restrictions that there will be no animal harassment. Contractors will also be responsible for fires. Discussion was held that they would be just west of the burning grounds of the Army Depot and be in a chemical area. McNeill stated that they had been cleared by Corps of Engineers and only working in cleared area. Russell questioned if there will be pictures taken of roads prior to work. Seiler will assess damages.

Susan Henderson served on the advisory board for Black Hills Army Depot and gave a

history of the clean up there, noting that she feels there are chemicals underground and it would be wrong to proceed. Cindy Brunson also spoke of concerns, noting unexplained animal deaths, advising no one be in the area. McNeill will research and take all things into consideration for where survey work will be done.

Public Comment was heard from Paul Nabholz and Cindy Brunson. Nabholz presented a copy of a Grant of ROW Easement filed in 1958 between F.O. Butler Ranch and the City of Hot Springs for maintenance on the Battle Mtn road. Nabholz has discussed this with emergency management.

Brunson wanted updates on Igloo Road, questioning if more gravel was provided and the pot holes fixed. Brunson also stated that there would be an open house at the bunkers near Igloo on May 19, 2017. Sheriff Evans stated that 500 people are expected for this. Falkenburg suggested that Susie Simkins will have to assess the leased ones as homes; people will only be buying bunkers, not land. Bunkers will be buildings on leased site.

Jim Ball met with the board to request road work and gravel on County Road 11 (Rocky Ford Road). Seiler drove it the week before; thought it was too soft right now to haul gravel. Seiler also wanted to pull shoulders before spreading gravel. Falkenburg stated they would work on it when the road dries up.

The first reading was held on a revised Ordinance providing for the regulation of engine or exhaust noise within Fall River County, with Allen reviewing changes from the last ordinance. Ben Tubbs gave input from his spending an hour at Maverick Jct, noting he feels that truck drivers will continue to use jake brakes. Discussion was held on the location of signs, with Seiler noting the state will not post a sign on Hwy 18 coming from the west. Otherwise signs could be posted north of Maverick Jct (Coffee Cup) and heading west from Hot Springs on Hwy 385. Russell still felt that enforcement was sketchy, but they needed ordinance for a sign. The goal was to remind everyone to be considerate, but to still use brakes for safety. More discussion was held on the pros and cons of the ordinance and safety. Motion made by Allen, seconded by Russell to approve the first reading of the Ordinance providing for the regulation of engine or exhaust noise within Fall River County. By a roll call vote, and Allen voting yes, all others no, motion failed. The ordinance will be brought back at a later date.

Brian Ahrendt, Deputy State's Attorney, presented a Real Estate Sales Contract for the 709 Jensen Hwy property, with June 19 as the proposed closing date. An inspection is recommended, and discussion was held on problems if found. It was noted that the inspection would be an opportunity to have the seller fix, or term the contract. Motion made by Russell, seconded by Nabholz to approve the Real Estate Sales Contract.

Motion made by Nabholz, seconded by Abbott, to have the building inspected, with an inspector of Jensen's choice.

Paul Nabholz spoke of a CD comparison between one owned by the county and one owned personally, and provided a chart. Nabholz also spoke of meetings he has attended - the SHEDCO meeting at Sunrise Ranch, an Ag land workshop and a RC&D meeting. Nabholz also asked for identifying information be removed on assistance application.

Nabholz also spoke of his campaign promise to remove or reduce the Wheel tax and spoke

of raising the wheel tax on vehicles that weigh 6,000 pounds or more to \$5 per wheel, and zero for all weights below. Nabholz stated that a higher cost for the 6,000 plus pounds give Fall River County higher odds to qualify the bridge funding. Nabholz has contacted ranchers about the increase; most feel it would be a wash for them. Concerns were noted by fellow commissioners on increased taxes for vehicles over 6000 pounds and if the loss of revenue would require more funds to be spent out of the general fund. Discussion continued on the subject.

Joe Allen, commissioner, discussed the county plan of action with the board. Discussion was held on possible changes needed at the Jensen Hwy property to comply with the SD Dept of Health requirements. Allen believes they need to start talking about the jail before moving offices. Falkenburg stated the need to wait for security assessment.

Motion made by Russell, seconded by Nabholz to adjourn as the Board of County Commissioners at 11:25 a.m.

Motion made by Abbott, seconded by Russell to reconvene as a 2017 Consolidated Board of Equalization to address final stipulations.

Motion made by Allen, seconded by Abbott, to approve stipulation for James and Peggy Woehl to reflect the discretionary value for agriculture buildings. Motion made by Nabholz, seconded by Russell to approve change to remove Owner Occupied status from Ruth E. Olson.

Motion made by Russell, seconded by Nabholz to approve the final 2017 Exempt and Owner Occupied stipulation list.

Motion made by Allen, seconded by Abbott to adjourn as a consolidated board of Equalization at 11:55 a.m.

FALL RIVER COUNTY MINUTES OF MAY 16, 2017

The Fall River Board of County Commissioners met in regular session on May 16, 2017. Present: Ann Abbott, Joe Allen, Joe Falkenburg, Paul Nabholz, Deb Russell and Sue Ganje, Auditor.

The Pledge of Allegiance was given and the meeting called to order at 9:00 AM.

The agenda was reviewed for conflicts; Russell had a conflict with the pipeline easement; Allen had a conflict on the malt beverage license; Falkenburg had a conflict with the resolution opposing the proposed deep injection wells by Azarga/Powertech. ALL MOTIONS RECORDED IN THESE MINUTES WERE BY UNANIMOUS VOTE, UNLESS OTHERWISE STATED.

Motion made by Russell, seconded by Nabholz, to approve the agenda as written.

Motion made by Nabholz, seconded by Abbott, to approve the minutes of April 11 and April 18, 2017 Consolidated Equalization minutes.

Motion made by Nabholz, seconded by Russell, to approve the April 18, 2017 minutes, with the correction to reflect motion seconded by Allen, not Abbott on the action on the WSD Community action commissioner's representative.

Motion made by Russell, seconded by Nabholz to defer the county burial to another meeting.

Motion made by Nabholz, seconded by Abbott to approve the April 30th, 2017 Auditor's Account with County Treasurer.

Motion made by Russell, seconded by Nabholz to approve the Agreement between the County and SD Department of Health for 2017 – 2018 WIC Services, and authorize the chairman to sign.

Lyle Jensen, Maintenance, presented a quote from Golden West. Motion made by Abbott, seconded by Allen to approve the Vipre Antivirus through Golden West Telecom for three years, in the amount of \$2,218.40.

Jensen reported on leveling gravel for the parking lot across the street, discussed drain access and wanted to talk to the neighbors. Motion made by Nabholz, seconded by Russell to authorize Jensen to spend \$3,000 or less for gravel and the Highway department to spread and level.

Jensen spoke of the phone system and the new 911 system and the upgrades needed, anticipating a cost of less than \$3,500. Motion made by Russell, seconded by Nabholz to approve up to \$3,000 to upgrade the phone system to be compatible with the 911 system.

Nabholz questioned if the county should be buying from the Ambulance Service rather than the District. Jensen spoke of the building inspection.

Nabholz presented suggestions for changes to the Code of the West. Motion made by

Nabholz, seconded by Abbott to adopt the Code of the West, with changes addressing high speed internet and road miles.

Jim Sword, State's Attorney, met with the board to discuss the building inspection on the old Ambulance building. One window is cracked, three windows are without seals and the furnace igniter needs to be fixed, with the Ambulance Service agreeing to fix those issues. The closing date was discussed. Motion made by Russell, seconded by Nabholz to defer the closing for two weeks.

Nabholz advised he is continuing to get DOT updates dealing with the wheel tax; he hopes for an ordinance in June. With his proposed changes, there will be an increased chance to get bridge improvement grants. Falkenburg stated that he and other commissioners do not support a change. Nabholz stated that the DOT did not tell counties that a wheel tax on only 6,000 tons was needed to qualify for the grant funding.

Michael P. Ortner, Attorney, met to present a petition. Motion made by Allen, seconded by Abbott, to set a hearing for a petition to vacate a street for Brian and Bonnie Holland and Kevin and Irma Fees on June 6, 2017 at 11:00 a.m.

Joe Allen spoke of the recent proposed noise ordinances, wanting board agreement on prior issues addressed, including fines, locations, need for maximum 80 DB pulse meter and enforcement. Motion made by Russell, seconded by Abbott to defer discussion on Jake brakes until the June meeting.

Angel Cope, of Edgemont, met to ask for a signature for a variance, as the county highway shop is a neighbor. Falkenburg wondered why at the county level. Mayor Jerry Dibble had sent Cope to the County. Motion made by Nabholz, seconded by Russell to approve signing the application for the variance from the zoning ordinance for the City of Edgemont and authorizes the chairman to sign.

Motion made by Nabholz, seconded by Abbott, to approve all malt beverage licenses, with the exception of Forney's. With Allen abstaining, all others voting yes, motion carried.

Motion made by Abbott, seconded by Nabholz, to approve Forney's malt beverage license, including the addition of Twila Forney's name on the application. With Allen abstaining, all others voting yes, motion carried.

Randy Seiler, Highway Superintendent, met with the board and requested purchase of a gravel retriever to assist with pulling back gravel from the side of the roads. Motion made by Russell, seconded by Abbott to approve the purchase of a Gravel Retriever in the amount of \$16,500.

Motion made by Nabholz, seconded by Abbott to approve the pipeline easement for Gene and Deb Russell, in that area adjacent to the SW Quarter of Section 25 in Township 7, Range 7, and the NE Quarter of Section 36 in Township 7, Range 7, of the Black Hills Meridian, Fall River County, South Dakota and the pipeline to run from the NE Quarter of Section 36 in Township 7, Range 7, to the WSW Quarter of Section 25 in Township 7, Range 7 of the Black Hills Meridian, Fall River County, South Dakota. With Russell abstaining, all others voting yes, motion carried.

Motion made by Abbott, seconded by Russell, to approve travel for Ken Martin to attend DWare training in Oacoma, on June 21 and June 22, 2017.

Motion made by Nabholz, seconded by Russell, to approve travel for Randy Seiler to attend the summer highway meeting on June 7 and June 8, 2017 in Pierre.

The board asked Seiler to check status on Chilson Bridge and the Argentine Township Bridge. Susan Henderson questioned if the Igloo Bridge will hold up if 500 people visit, which it will.

Seiler spoke of meeting with Brosz and Simons on the Igloo road, discussing fencing requests. Falkenburg referred to the state's attorney; Sword asked for the highway superintendent's recommendation. A portion of the road on the Igloo road may be a state issue (by the auto gate).

Break was taken at 10:10 a.m. Meeting resume at 10:19 a.m.

No public comment was heard. Brief discussion was held on agendas. Nabholz got a copy of an easement from the City of Hot Springs and looked at the 1958 minutes and found that the Kiwanis has asked the City to gravel for a campground on Battle Mountain Road; no agreement was found. Frank Maynard thought the state was responsible but they ran out of money; other options could be explored on getting to the towers.

Maynard, Emergency Management, met with the board to advise of a County Rangeland Fire Protection Agreement; would like to review further and get a resolution together. Motion made by Abbott, seconded by Nabholz, to defer the County Rangeland Fire Protection Agreement to the next meeting.

Maynard spoke of need for a continuity of operations. He will be working with each office to determine needs and alternative temporary sites in the event of an emergency. Maynard said the county received \$9,868 for reimbursement for panic buttons; the Parker Peak Fire burned 5 acres; a property had a propane leak and there was a gas spill.

Falkenburg asked about the courthouse security assessment. There are changes that can be made immediately, and policies needed. Motion made by Allen, seconded by Russell, to approve

Maynard to write a grant for Courthouse Security needs after hearing from the Court System.

Sue Ganje, Auditor, presented a ytd budget for review and requested hire approval. Motion made by Russell, seconded by Abbott to approve hire of Tiffany Brophy at \$12 per hour, as per union contract, effective immediately.

The Commission continued discussion on the security assessment. Falkenburg questioned Sheriff Evans about what it would take to bring in local firearm training. John Taylor, Hot Springs Star, believes that there could be a couple in the gun club who could give training. Falkenburg will set up a tour of the jail for the next meeting.

Joe Allen presented a resolution for consideration to oppose the issuing of permits for deep injection wells by Azarga/Powertech. Falkenburg announced that people would get five minutes each to comment after the speakers, that there would be no recording devices and an orderly discussion would be held during the 11 a.m. portion of the meeting. Hollenbeck requested equal time at a later date.

Lindsey McLean, federally approved expert and bio chemist in toxicology, gave an overview of heavy metals and toxins. McLean also spoke of deformities that could happen in animals and health effects, even below the legal levels. Falkenburg added that deformities could happen in animals from other causes than uranium. McClean added that metals cannot be detoxified and believes that we could get sick from eating the plants and animals that have been exposed to uranium. McClean also asked the commissioners to pass the resolution.

Dr. Legary, Oglala Lakota College professor and also an approved federal expert, discussed research done by college students and other research he has done. He is a representative for the Native Americans.

John Davis, John Sides, Marlene Akhtar, Gardner Gray, Debra Johnston, Sarah Peterson, Michael Valandra and others spoke against the possibility of mining the uranium. All were concerned about the hazards that could occur by mining the uranium and hazards to the water, as well as effects on tourism.

Kurt Barker was concerned about McLean and other presenters showing up to a commissioner meeting. If the NRC board and EPA have already cleared things and are considering issuing permits, why were the presenters there?

Mark Hollenbeck, chemical engineer and Fall River County resident, gave a short presentation on the pros of having the uranium mined. Hollenbeck stated facts matter and the rights of the minority can't rule. The water near the site in Edgemont is not drinkable; good wells hug the boundary of Black Hills. The EPA has studied this issue for seven years, with scientists. Hollenbeck invited the commissioners to see the site near Edgemont and felt a hearing in Edgemont could be a good thing. Hollenbeck would also like to see studies from the opposition.

Nabholz stated the water was staying within the reservoir and that wells remove hazard from Inyan Kara, and again noted that nobody opposed to the mining was present at the Hydrology Conference. Russell and Abbott spoke of not being scientists or hydrologists, and even with concerns of the water are not qualified to make that decision.

Falkenburg tried to close the meeting and call for a vote on this. Abbott questioned if she should recuse herself since she sat on the NRCS board. Falkenburg thought she would be fine.

Allen has not heard anything about mining to keep water safe and there are no safe guards as a county or guidelines assurances. Allen read a resolution to oppose uranium mining. Motion made by Allen to approve said resolution. Motion died for a lack of a second. Numerous comments were directed to the board.

Allen left the meeting at 12:09 p.m.

Motion made by Russell, seconded by Abbott to enter into executive session for personnel as per SDCL 1-25-2 (1) at 12:12 p.m.

Meeting resumed at 12:19 p.m. Motion made by Abbott, seconded by Russell to adjourn the meeting at 12:20 p.m.

Also, note that the program will have nearly doubled in available funds by 2019 making the move to a \$5/wheel tax even more valuable.

Hi Paul,

58.25% of the license plate fees collected by the county are combined with 57% of the license plate fees that are state collected and sent into the State Secretary of Revenue. Those fees are split four different ways:

1. 1% goes into the state license plate special revenue fund
2. 0.5% goes into the state motor vehicle fund
3. 41.5% is redistributed to Individual County Road and Bridge Fund in the following manner: 25% by population, 25% by registered trucks, and 50% by total road mileage
4. The remaining 57% goes into the Local Government Highway and Bridge Fund and is further split 4-ways:
 - a. \$7 million / year (\$1.75m/quarter) is transferred into the BIG Fund
 - b. The remainder is sent back to the counties, municipalities, and townships per percentages established in SDCL 32-11-35 (Fall River gets 0.8157379401%, Hot Springs gets 0.12752369%, Edgemont gets 0.0506521496%, Oelrichs gets 0.0092873291%, and Fall River gets 0.0318493078% for the secondary roads & the two Townships)

The \$7 million / year from 4.a. above into the BIG fund is combined with \$2 million / year from the Transportation Commission from the State Highway Fund until we complete the Federal Bridge Program in 2018. In 2019, the Transportation Commission has elected to add \$6 million / year that was previously used in the Federal Bridge Program so the total will go from \$9 / year currently to \$15 / year in 2019 available for grants.

While I wanted the 0/0/0/5/35 wheel tax, the proposed 1/1/1/5/20 still provides a tax cut, snags the higher grants, and increases county revenue. Also attached are the proposed ordinance, based on the original, and the editorial I have scheduled for the HS Star on May 30th. I'd like to have the ordinance on the agenda for the next meeting and you could include this in the packet. I have a lot of forwarded spreadsheets from Kinniburgh, Laurie Schultz (DOT), and Heather Villa (Revenue), but that is probably more than most of us need. Sue, let me know if the Sept 1 start date allows time for the correct notifications to be mailed in August.

As you know I would like to drop the wheel tax on lighter vehicles to zero and raise it to \$5/wheel on heavier vehicles. That provides a tax break for most residents, but reduces county tax revenue. However, the huge thing that stands out after reviewing the BIG program results is the necessity of having a \$5 wheel tax on 6000# plus vehicles. Only one county with a \$2 wheel tax, like ours, got any replacement/rehabilitation funding from 2016-2017. Nine counties with \$4 or 5 wheel taxes got funding from 2016-2017. The average annual funding for \$2 wheel tax counties was only \$12,000 per year. For \$4 or 5 wheel tax counties it was \$72,000 per year.

It only makes sense for us to try and capture the increased funding, an additional \$60,000/year, that is available to \$4 or 5 wheel tax counties. Of those counties with a wheel tax, 43 have \$4 or 5 and only 15 below \$4. Hughes County went up to a \$5 wheel tax on only the 6000# plus vehicles starting this year.

Our current tax revenue from the wheel tax plus the average BIG repl/rehab grant is \$105,000 plus \$12,000 or \$117,000/yr. If we kept the existing \$2 on lighter vehicles and raised the tax on heavier our tax

revenue would rise to \$122,300 plus \$72,000 or \$194,300 a 65 percent increase in average county revenue. However, the tax increase would mainly be on farmers, ranchers and contractors and the increase to \$5 would likely be referred.

To capture the funding, increase revenue, and give the majority of residents a tax break we could halve the wheel tax on lighter vehicles, go to \$5 on heavier, and drop the per vehicle tax cap to \$20. The tax would be 1/1/1/5/20. Our current tax revenue would rise to \$71,600 plus \$72,000 or \$143,600 increasing county revenue by \$26,600 or 23 percent. The total tax break for citizens would be \$33,400 or about 32% off the current wheel tax. Lowering the tax cap would limit any tax increase on farmers, ranchers, and contractors.

In summary, while I would like the bigger tax break, it is irresponsible to pass up the greater bridge funding obtained by the higher wheel tax on heavier vehicles. As Doug Kinniburgh SDDOT notes, see attached, "Going from \$2 to \$5 wheel tax on the 6000 lb + vehicles would be a huge benefit..." Forty-three SD counties already have \$4 or \$5 wheel tax on 6000 lb + vehicles, putting them ahead of us in line for funding. The 1/1/1/5/20 tax would move Fall River to the front of the line, get more average funding, and reduce the average citizen's wheel tax.

Deb makes a good point. Wheel taxes and property taxes both fund bridges and we can trade them between each other. But, with the state scoring we get an average \$60,000 more funding with higher wheel taxes on 6000#+ vehicles. That is a partial return of the increase in vehicle registration fees that we pay anyway.

Hi Paul,

Going from \$2 to \$5 wheel tax on the 6000 lb + vehicles would be a huge benefit to the BIG competition. That alone will garn you 6 points. This most recent replacement grant award had 4.13 points between top award and the first unsuccessful applicant. Your bridge inspector can work through some different scenarios with you with regard to local financial impact to the scoring system and apply that to each bridge you have identified in the 5 year plan if you so desire or any one in particular.

Yes, currently your existing projects are under the old program and with regard to the Chilson Bridge, I think we still have several options that can be considered including an at-grade crossing but not on the existing alignment.

Appreciated your talk at the spring training regarding the wheel tax. We are looking at possibly lowering the tax on below 6000# vehicles and raising the tax to the max on 6000# plus vehicles. Heather at Revenue is trying to give me the number of vehicles in each class for Fall River County so we can see what it would do to tax revenue. My question for you is whether the gain from going from \$2 to \$5 per wheel on 6000# plus vehicles gains us much in the funding formula. Do you have a list of engineering/bridge applications, how each was scored on safety/traffic/wheel tax, their total scores and which projects were funded and for how much they were funded? I am trying to see if the wheel tax scoring greatly improves the chances of being funded or if safety/traffic concerns overwhelm the results. Given lead times are we actually funding under BIG now or is everything from past programs. My understanding is the old 18 bridges are under a previous scheme. I still like at grade, but Eberle makes it sound like we could not raise the Michelson trail to keep the same routing with just elevation changes.

ORDINANCE #2017-01

AN ORDINANCE FOR THE IMPOSITION, COLLECTION, AND ENFORCEMENT OF A
REVISED WHEEL TAX IN FALL RIVER COUNTY

WHEREAS, the South Dakota State Legislature created, through the enactment of Senate Bill 1, during the 2015 Legislative Session, the Local Bridge Improvement Fund and any funds deposited into such Fund is continuously appropriated to the South Dakota Department of Transportation.

WHEREAS, the Department of Transportation may award grants from such Fund to any county which has adopted and annually updated its county highway and bridge improvement plan and has imposed a county wheel tax pursuant to SDCL 32-5A-1.

WHEREAS the Fall River County Commission has determined that grants from the Local Bridge Improvement Fund and revenue from the adoption of a wheel tax is needed for highway and bridge maintenance and construction and the County needs more funding for such purposes.

BE IT ORDAINED BY THE FALL RIVER COUNTY COMMISSION that a wheel tax pursuant to SDCL Chapter 32-5A, as amended, and consistent with legislative intent requiring Counties to impose and administer a wheel tax, is imposed in and for Fall River County as set forth herein

:

Section 1:

All motor vehicles as defined in SDCL 32-3-1, registered in the County shall have a wheel tax imposed upon each vehicle at a rate not to exceed One Dollar (\$1.00) per vehicle wheel for vehicles weighing under six thousand pounds (6,000 lbs) and at a rate not to exceed Five Dollars (\$5.00) per vehicle wheel for vehicles weighing over six thousand pounds (6000 lbs).

Section 2:

The wheel tax shall be collected and administered by the County. The per vehicle wheel rate shall be the same for all types of motor vehicles and the total vehicle tax may not exceed Twenty Dollars (\$20.00) per vehicle.

Section 3:

The proceeds from the tax created by this chapter shall be retained by the county, deposited in a special highway fund and the revenue may be used only for highway and bridge maintenance and construction. The Board of County Commissioners shall, by resolution, establish a means of distributing the revenue generated by this chapter among the county, municipalities and townships located within the county.

Section 4:

Upon purchasing a vehicle from a dealer, the purchaser shall pay the appropriate tax at the time of title transfer. Nothing in this ordinance shall prevent an automobile dealer from licensing the vehicles on his lot without paying any taxes created by this ordinance.

Section 5:

This ordinance shall cover and impose the wheel tax for all motor vehicles eligible for license registration or license renewal for January, 2018, and all subsequent months. This ordinance shall impose a wheel tax upon all motor vehicles so described, even though license registration or renewal takes place before January 1, 2018.

Section 6:

Pursuant to SDCL 32-5A-7, if a motor vehicle is licensed for a period of time of less than twelve months, any wheel tax imposed on such motor vehicle pursuant to this ordinance shall be prorated on a monthly basis.

Section 7:

If any provision of this ordinance shall be held invalid, it shall not affect any other provisions of this ordinance that can be given effect without the invalid provision, and for this purpose, the provisions of this ordinance are hereby declared to be severable.

Our Services

Counseling Services: Counseling from a trained professional is a proven method of dealing with emotional and behavioral problems that often seem overwhelming. Our outpatient counselors are all master's level professionals with years of experience in a variety of areas including but not limited to depression, anxiety, grief and loss, marriage & family issues, adjustment to divorce, attention deficit hyperactivity disorder (ADHD), teen problems, and suicide and crisis intervention. We also offer a number of groups covering a variety of topics. Please contact us to find out which groups we are currently offering.

CARE/Impact: The CARE program serves adults recovering from a severe and persistent mental illness on an outreach basis, usually in the client's home or other community setting. The CARE team includes therapists, case managers, psychiatrists and Certified Nurse Practitioners. Individualized treatment planning allows us to support client's progress towards meeting their personal goals. Case managers work with the client and others to see that basic needs are met such as obtaining medical and dental services, locating safe, clean, affordable housing, finding assistance from social services agencies, understanding the community transportation system, maintaining personal hygiene, assistance with medication management, performance of household chores, budgeting, and developing social and independent living skills. Group therapy is another service provided by the CARE team and is often the treatment of choice for many individuals. In addition, we believe employment is a key step in gaining independence, but for many adults with a severe mental illness, finding and keeping a job can be extremely difficult. Through our Vocational Program, we encourage clients to choose, get, and keep the job of their choice. Our training program covers work place attitude, interviewing techniques, skill identification, communication skills, and compiling information for a resume or application.

Residential: Our Residential program provides a safe living environment for adults recovering from major mental illnesses by helping individuals acquire the skills needed to successfully live independently. Through a structured environment, we assist clients with social and recreational activities, provide education on basic living skills, and ensure medication is properly administered. The goal of this program is to help clients transition into their own living arrangements.

Family Pathways: Family outreach services provide treatment to children and adolescents with serious emotional or behavioral problems in the family setting and with family participation. Services are available to the child, their parents or guardian, and any siblings or other household members. Counselors work in families' homes, schools, and in other community settings to make sure these young people get intensive counseling and support from a variety of service providers. Family Pathways serves children from birth to age 18.

Full Circle: Full Circle is a residential substance abuse treatment and prevention program designed for pregnant women and mothers with alcohol and/or drug problems which are impacting their ability to be a good parent. 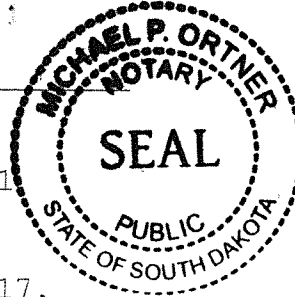

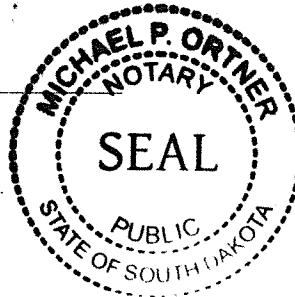

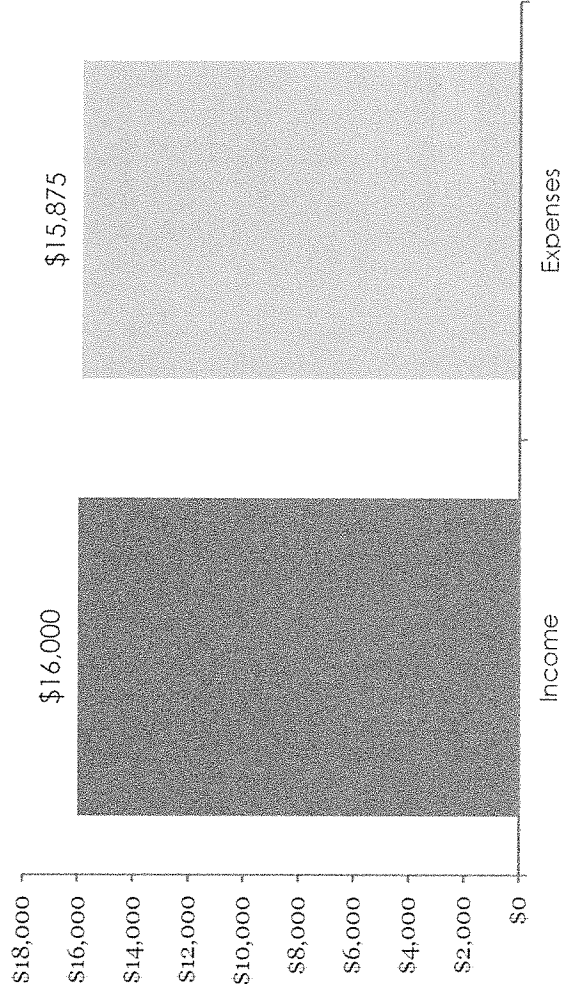
