The Fall River Board of County Commissioners met in regular session on December 15, 2015 in the courtroom of the Courthouse. Present: Joe Allen, Joe Falkenburg, Michael Ortner, Deb Russell and Sue Ganje, Auditor. Absent: Ann Abbott.

The Pledge of Allegiance was given and the meeting called to order at 9:00 AM. ALL MOTIONS RECORDED IN THESE MINUTES WERE BY UNANIMOUS VOTE, UNLESS OTHERWISE STATED.

The agenda was reviewed for conflicts. Motion by Falkenburg, seconded by Allen to approve the agenda as written.

Motion by Falkenburg, seconded by Allen, to amend the 11/17/15 minutes to include: a salary increase for Karen Jamison to \$16.50 an hour, effective on the 1/1/16 pay period. This increase includes the \$.75 January cost of living increase.

Motion by Falkenburg, seconded by Ortner, to amend the 12/1/15 minutes to remove the word "para" when discussing wind and confined livestock.

Clint Anderson presented a current map of property across River St. from Courthouse, noting issues with County owning a portion of the Braun Hotel driveway into their parking. Board requested possible trade of land. Lyle Jensen, Maintenance Supervisor will look into this.

Mike Ortner reported on the NACO Board meeting he attended in Colorado Springs, CO, which mainly focused on individuals in jail with mental health issues and cyber security. Ortner met with the BN railroad Officials concerning the blocking of SD Hwy 471 S., and reported a Mgt. change at the regional level; he received an e-mail stating this is cleared up now. A brief was also given on the SDACC Board meeting, mostly on upcoming legislation that has been the result of 2015 SB 1, that should help counties with funding.

Jensen gave specifics on the Homeland Security grant that was applied for and approved for door proximity swipes to enter the Courthouse and Jail. He and the Commissioners discussed the specifics of the coverage's. He also advised the Board that the State 911 Dispatch is being reviewed by State 911 for an upgrade to current PSAP. Motion by Ortner, seconded by Falkenburg to approve the Homeland Security grant quote in the amount of \$20,469.60, and allow Supervisors to have key swipes to the Building. The State's Attorney employees will have swipes for the jail to come through to the Courthouse to work outside of courthouse hours.

Frank Maynard, Emergency Management, advised Board the generator was set in Oelrichs and the propane will be installed soon. Motion by Falkenburg, seconded by Allen to approve payment of the bill before year-end to get packet submitted to the State for reimbursement Homeland Security bill.

Motion by Falkenburg, seconded by Ortner to approve travel for Frank Maynard to the SD Fire Institute Conference on 1/9/16 & 1/10/16.

Edie Jenniges gave a review to the Board on the Sexual Violence Institute Conference she attended in Sioux Falls. Falkenburg suggested coordinating with W.E.A.V.E.

The Commissioners took a break at 10:27 am. and reconvened at 10:35 am.

During public comments the Board heard from Susan Henderson on: requesting a task force for protection of water and other vital resources, a report from the State on the increase of taxes and the jail building. The Board was urged to hold the line on spending.

Susie Simkins, Director of Equalization met with the Board on two abatements. Motion by Falkenburg, seconded by Ortner to approve an abatement on the advanced mobile home taxes to Tony Otteson on parcel 81900-0000-00135 for a total of \$85.12. Reason: Sale of the mobile home did not go through after taxes were generated.

Motion by Falkenburg, seconded by Ortner to approve a tax refund of the advanced mobile home taxes to Cleve Janis on parcel 81900-00000-04020 for a total of \$55.49. Reason: Sale of the mobile home did not go through after taxes were generated.

Josh Buckwheat, Deputy Sheriff, discussed with the Board the two vehicles budgeted for 2016, and the cost of the 2016 LE vehicles off of State bid coming in at \$6,000 per vehicle more than budgeted. Buckwheat proposed that they also use a trade-in. After additional discussion, a Motion was made by Falkenburg, seconded by Allen to purchase one new Tahoe, original cost of \$37,650, and allow trade-in of the 2010 Tahoe, for a county cost of \$29,835.

Discussion regarding changing the State's Attorney position from part-time to full-time was held. The Board asked for time to think on this issue.

Greg Foust. Executive Director Fall River Housing & Redevelopment Commission requested approval of James L. Stevens to fill the 5-year term on the Board effective January 1, 2016. Motion by Falkenburg, seconded by Allen to approve the appointment of Jim Stevens to a 5-year term on fall River Housing & Redevelopment Commission effective 1/1/2016.

Motion by Falkenburg, seconded by Ortner to approve the following contingency transfer; supplements and resolution.

Jim Sword, State's Attorney discussed with the Board information and possible licensing of solar, wind and confined livestock industries.

Motion by Ortner, seconded by Falkenburg, to move into executive session for personnel issues at 11:41am. Commissioner's returned from executive session at 11:51am.

In executive session it was noted, Martha Jarman, (previous FR County Deputy Sheriff) has accepted a Dispatcher position. Martha's pay will remain the same, and the effective date of this transfer will be December 21, 2015.

With no additional action taken, motion by Falkenburg , seconded by Ortner to adjourn at 11:52 pm.




