The Pledge of Allegiance was given and the meeting called to order at 9:00 a.m.

The agenda was reviewed for conflicts; none were noted. ALL MOTIONS RECORDED IN THESE MINUTES WERE PASSED BY UNANIMOUS VOTE, UNLESS OTHERWISE STATED.

Motion made by Russell, seconded by Nabholz to surplus to junk the Auditor's Office printer #1878.

The Board reviewed a letter from Barb Cline, Executive Director for Prairie Hills Transit. The letter addressed the new bus that is now in Hot Springs and is wrapped in Veteran style; the amount of the local cash match in the amount of \$11,504.04 and the total bus cost of \$59,217.20. The letter also noted a 50% cut in the local cash match from the City of Hot Springs for 2018. Falkenburg and Russell discussed what they understood to be the reason for the decreased funding for PHT in 2018 from the city, and Russell relayed her conversation with the Mayor of the City. The board wondered what other organizations contributed towards the bus funding. Nabholz shared concerns about how it was hard for poor people to pay for the service.

Motion made by Russell, seconded by Russell, to set an annual bid hearing for February 6, 2018 at 10:10 a.m.

Discussion was held on a meeting with the South Dakota DOT on January 3, 2018 to discuss the Chilson and Igloo bridges.

During public comment, Susan Henderson spoke of a letter to congress representatives on the \$10,000 cap on SALT (state and local taxes), the Chilson Bridge and noted her opposition to the building of a new jail.
