#### FALL RIVER COUNTY MINUTES OF JANUARY 8, 2019

The Fall River Board of County Commissioners met in regular session on January 8, 2019. Present: Ann Abbott, Joe Allen, Joe Falkenburg, Paul Nabholz, Deb Russell and Sue Ganje, Auditor. The Oath of Office for newly elected commissioners has been placed on file in the Auditor's office.

The Pledge of Allegiance was given and the meeting called to order at 9:00 a.m.

The agenda was reviewed for conflicts; none were noted. ALL MOTIONS RECORDED IN THESE MINUTES WERE PASSED BY UNANIMOUS VOTE, UNLESS OTHERWISE STATED.

Motion made by Russell, seconded by Abbott, to approve the agenda as written.

The meeting was turned over to the Auditor who asked for nominations for the Chairman of the Board. Motion made by Abbott, seconded by Allen, to nominate Falkenburg as chairman for 2019.

Motion made by Russell, seconded by Nabholz that nominations for Chairman cease. Falkenburg is Chairman for the 2019 year. The meeting was turned back to the Chairman of the Board.

Motion made by Nabholz, seconded by Falkenburg to nominate Russell as Vice-Chair.

Motion made by Abbott, seconded by Nabholz that nominations for Vice-Chair cease. Russell will serve as the 2019 Vice-Chair.

Motion made by Nabholz, seconded by Abbott, to set the Fall River County Herald and the Hot Springs Star as the official legal county newspapers for 2019.

Nina Steinmetz, Weed Supervisor, met with the board. Motion made by Allen, seconded by Abbott, to approve travel for Steinmetz and Bob Novotny to attend the SD Weed and Pest Conference in Huron, SD on February 19 and February 22, 2019, total cost in the amount of \$1,062.00.

Cindy Brunson made note of prairie dog issues in the area.

Frank Maynard, Emergency Management, met with the board to advise that the county has received the 4<sup>th</sup> quarter 50% reimbursement for the SLA (State and Local Agreement) totaling \$11,357.82. Maynard will have the first quarter SLA report ready by the next meeting, which will now require more information to be included in the report.

Discussion was held on a possible county wide notification system such as CodeRED from Onsolve. This would allow messages to get out county wide easier in case of emergency or court house closure. Maynard will do some more checking and get back to the board at a later date.

Maynard also updated the board on recent fires and incidents. Nabholz requested Maynard get with Lyle Jensen regarding the missing impact barriers in front of the courthouse propane tank.

Randy Seiler, Highway Superintendent, met with the board, noting the need to stock pile gravel again at Shep's Canyon. Seiler will go back to state specs with the bid. Discussion was held on the contractor being responsible for sampling; more discussion will be held at the next meeting, along with a request to purchase a couple pickups out of this year's budget. Seiler also advised that they will be running four gravel trucks now.

Cindy Brunson had concerns about the Fort Provo road. Discussion was held concerning this topic.

Motion made by Russell, seconded by Allen to appoint Randy Seiler as Highway Superintendent as per SDCL 31-11-1 for a term of January 2019 through January 2021. With Nabholz voting no, all others voting yes, motion carries.

Break was taken at 10:16 a.m. and the meeting reconvened at 10:23 a.m.

Public comment was heard from Jim Angell and Cindy Brunson. Angell spoke of the poisoning of hawks from the lead used in shooting prairie dogs; Brunson had questions about the flight for life insurance and questioned the policy of the Treasurer's office that taxpayers had to provide stamped envelopes to receive tax payment receipts. The Treasurer noted that receipts had been mailed out in the past as a courtesy.

Dan Cullen, Veteran's Service Officer, met with the board to present his fourth quarter and year-end report. 272 awards were made in the fourth quarter of 2018 in the amount of \$578,002.52. When Cullen started four years ago, 1200 veterans were registered within the county. There are now 1900 registered veterans.

Stacy Martin, GIS, met with the board. Motion made by Nabholz, seconded by Allen, to authorize Martin to purchase a new computer with an approximate cost of \$1,000.00.

Discussion was held on 911 sign replacement. The board agreed occasional updates and/or approval for purchases of \$400.00 or more would be often enough for Martin to meet with them on this project.

The board also asked that Martin help Maynard with the possible new procedure in notifying the county of emergencies. Martin provided a breakdown of the taxes in the county. This information is on the county website.

Allen left the meeting at 10:41 a.m.

Bob Evans, Sheriff, met with the board. Motion made by Nabholz, seconded by Russell, to approve the Pennington County memorandum of understanding between Western South Dakota Juvenile Services Center and Fall River County of South Dakota.

Motion made by Nabholz, seconded by Russell, to approve the quote from Rushmore Communications for speaker mics and leather cases with swivels in the amount of \$1,043.00 for their handheld radios.

Motion made by Russell, seconded by Abbott, to hire Justin Hayne, part time, \$18.00 per hour, to man the metal detector on court days.

Evans also reported about numbers in the jail at that time. There are 10 prisoner in the Fall River County Jail, with 2 prisoners being held in the Pennington County Jail.

Motion made by Nabholz, seconded by Russell to enter into executive session for legal purposes as per SDCL 1-25-2 (3) at 10:55 a.m. with deputy state's attorney Ahrendt.

Meeting resumed at 11:03 a.m.

Motion made by Nabholz, seconded by Russell, to adjourn at 11:04 a.m.
