FALL RIVER COUNTY APPROVED MINUTES OF JULY 2, 2019

The Fall River Board of County Commissioners met in regular session on July 2, 2019. Present: Ann Abbott, Joe Allen, Joe Falkenburg, Paul Nabholz, Deb Russell and Sue Ganje, Auditor.

The Pledge of Allegiance was given and the meeting called to order at 9:00 a.m.

The agenda was reviewed for conflicts; none were noted. ALL MOTIONS RECORDED IN THESE MINUTES WERE PASSED BY UNANIMOUS VOTE, UNLESS OTHERWISE STATED.

Motion made by Russell, seconded by Nabholz, to approve the agenda, as written.

Motion made by Nabholz, seconded by Russell, to approve the June 18, 2019 minutes.

Motion made by Abbott, seconded by Allen, to approve pay raises for Daniel Leetch (Deputy Sheriff), effective, June 20, 2019 from \$15.25 to \$15.50 (2080 hours); Trina Simunek (Dispatch), effective June 17, 2019, from \$13.50 to \$14.56 (4160 hours) and Carol Boche (State's Attorney), effective June 27, 2019, from \$11.00 to \$12.00 (2080 hours), all as per union contract.

Motion made by Nabholz, seconded by Allen, to deny CP 2019-8, above income guidelines.

Motion made by Abbott, seconded by Russell, to surplus to junk a Netgear wireless router, law library, #01987, and Gateway laptop computer, Emergency Management, #01566.

Motion made by Russell, seconded by Allen, to surplus a 2011 Tahoe to transfer to another government entity (Oglala Lakota County Sheriff's Office). Nabholz suggested a possible letter to recipients of such actions.

Motion made by Nabholz, seconded by Abbott, to approve setting a contingency and supplement hearing for July 16, 2019 at 9:30 a.m.

The general fund surplus analysis through March 31, 2019 was reviewed.

Melody Engebretson, Register of Deeds, met with the board. Motion made by Nabholz, seconded by Abbott, to approve hiring Becky Wendland, effective July 8, 2019, \$12.00 per hour, as per union contract.

Motion made by Nabholz, seconded by Russell, to approve the agreement with CSC for electronic filing and authorize the Register of Deeds to sign, contingent on review by the State's Attorney.

Stacey Martin, GIS, met with the board to present her 2020 requested budget for 911 replacement sign project.

Motion made by Abbott, seconded by Nabholz, to approve the quote from Newman for 911 replacement signs, in the amount of \$2,165.77 for 2019 installation.

Lyle Jensen, Building Supervisor, met with the board and presented his 2020 requested budget.

Motion made by Allen, seconded by Abbott, to allow Jensen to explore costs to move dispatch to the jail garage.

Motion made by Abbott, seconded by Nabholz, to allow Fall River County to combine with the City of Hot Springs and Hot Springs school in a surplus auction to be held this fall.

Motion made by Allen, seconded by Russell, to transfer a computer from maintenance to the law library and approve a new computer purchase for maintenance.

Motion made by Allen, seconded by Nabholz, to approve the quote from Blindster for blinds in the Clerk of Courts office, in the amount of \$1,124.68.

Kelli Rhoe, Treasurer, met with the board to ask about utilizing a local realtor for the upcoming tax deed sale, with one realtor expressing interest. More discussion will be held at the next meeting.

Motion made by Allen, seconded by Russell, to approve the purchase of a 37-month CD in the amount of \$500,000.00. With Nabholz voting no, all others voting yes, motion carries.

Frank Maynard, Emergency Management, met with the board. Motion made by Russell, seconded by Abbott, to approve hiring Kaylon Russell, part time temporary, effective June 26, 2019, at \$10.00 per hour in the EM office.

Discussion was also held on usage of the 4th floor of the museum for an artist's exhibit. Maynard was asked to review the fire codes for that floor, and based on the NFPA code references 101, Life Safety Code and 914, Code for the Protection of Historical Buildings, he recommended usage. He noted two separate and remote exits, fire alarm pull boxes, smoke detectors and recommended limiting occupancy to 25 or fewer individuals at a time. The county does not accept any responsibility for any damage to exhibits, the museum would be liable.

Maynard updated the board about the Pre-Disaster Assessment (PDA), Pre-Disaster Mitigation (PDM), advised that Becky Peterson is the new Region 4 Coordinator. Maynard also discussed the 2019 Sturgis rally meeting, fires and incidents.

Carol Sides and Uriah Luallin, Fall River County Museum, met with the board to discuss activities, including the exhibits that will be displayed on the fourth floor of the museum, a new conference and meeting room, and the offer by Russell Wyatt to donate some antique farm equipment for display. They asked if the county could provide gravel for the farm equipment display, and asked for assistance moving the Lady of Lourds Stone.

Sides asked about workman's compensation for their employees, and if there is double coverage on liability insurance, as the museum and county both carry that insurance. The auditor will research the issue.

Paul Nabholz, Commissioner, met with the board to advise of upcoming local enhanced carry training at the Gun Vault in Edgemont on July 13th and at Southern Hills Tactical, July 28th. He made an offer to pay for employee enhanced carry training.

Motion made by Nabholz, seconded by Allen, to stay the motion to allow carry in the courthouse until August 7, 2019. Russell made a motion to amend the motion without an implementation date on it so it will be easier to get the issues with the insurance resolved. Discussion was held on the need for a firm date to encourage a speedy response by insurance for recommendations, time frame, etc. Russell withdrew her amendment. The original motion carried.

Nabholz updated the board on a recent meeting with Ali from the Black Hills Council of Local Government, on the Bulldoze, Build and Beautify grant, with only one grant completed in Aberdeen. The non-profit (Sub-applicant) typically provides the scope and need, costs and replacement housing. SHEDCO will be working on such estimates. Nabholz briefly discussed Hwy 471 and the Lookout Solar Energy Facility.

Kyle Steinbrook, Director of the Hot Springs Boys and Girls Club and Robin Paldson met with the board to present their 2020 requested budget.

Joe Allen, Commissioner, met with the board to discuss a proposed ordinance on dynamic brake devices. Motion made by Allen, seconded by Nabholz, to set a hearing for the first reading of Fall River County Ordinance #2019-01, an ordinance prohibiting the use of dynamic brake devices in specified locations within Fall River County, for July 16, 2019.

Randy Seiler, Highway Superintendent, met with the board. Motion made by Nabholz, seconded by Allen, to approve hiring Eric Shull, effective July 8, 2019, \$15.05 per hour, as per union contract.

Motion made by Allen, seconded by Russell, to allow Seiler to advertise for 2 temporary employees for mowing, etc., during the summer months.

Seiler advised the board that someone was interested in buying the old Cheyenne River Bridge. More discussion will be held at the next meeting. Seiler also advised the board that Game Fish and Parks will be paying up to \$15,000.00 for dust control at Shep's Canyon.

Motion made by Nabholz, seconded by Russell, to approve the following resolution:
