The Fall River Board of County Commissioners met in regular session on September 16, 2021. Present: Joe Allen, Les Cope, Joe Falkenburg, Heath Greenough, Deb Russell and Sue Ganje, Auditor.

The Pledge of Allegiance was given, and the meeting called to order at 9:00 a.m.

The agenda was reviewed for conflicts; none were noted. ALL MOTIONS RECORDED IN THESE MINUTES WERE PASSED BY UNANIMOUS VOTE, UNLESS OTHERWISE STATED. Chairman Falkenburg recognized Commissioner Russell as the outgoing president for the South Dakota Association of County Commissioners for the last year.

Motion made by Greenough, seconded by Allen, to approve the agenda as written.

Motion made by Russell, seconded by Greenough, to approve the minutes for August 19, 2021.

Motion made by Cope, seconded by Greenough, to approve sending letters to Representative Johnson, Senator Rounds and Senator Thune opposing a portion of the House Infrastructure Bill related to the freight rail system.

Motion made by Greenough, seconded by Russell, to approve surplus to junk an Intoximeter, #01864, Sheriff's Office.

Motion made by Cope, seconded by Greenough, to accept notification by Empower Coalition of the Southern Hills, of a raffle and a sale to raise funds for the Toys for Kids program.

Motion made by Russell, to approve CP 2021 - 05. After further discussion, Russell withdrew her motion.

Motion made by Cope, seconded by Greenough, to table CP 2021-05, for advice from the State's Attorney.

Frank Maynard, Emergency Management, met with the board, to report that he had attended an Edgemont City Council Meeting and Oelrichs Town Board meeting to provide updates to the county Pre-Disaster Mitigation Plan (PDM) and the Local Emergency Operations Plan (LEOP). Maynard will attend the Hot Springs City Council meeting on September 20, 2021 to do the required updates. Maynard also stated that the Fall River County annual exercise was held on September 15, 2021 and he will be completing the paperwork for full credit.

Motion made by Greenough, seconded by Allen, to approve the Lexipol virtual training modules for jailers, dispatch and law enforcement personnel training, along with office personnel in the amount of \$3,264.00 per year for 51 employees, to satisfy training compliance with safety benefits.

Maynard noted approval of the Homeland Security Grant in the approximate amount of \$68,000.00 for in-vehicle computers for Law Enforcement. Discussion was held on number of COVID-19 cases rising and precautions that could be put back in place for employees. The board agreed to putting the plexiglass back up but wearing masks should be up to the individuals. Maynard also reported fires and incidents.

The county received Gold and Platinum awards at the 2021 Safety Awards luncheon during the SD Counties Fall Convention and Commissioner Russell recognized Maynard for his completion of applications annually for the awards and initiating training for employees.

Bob Evans, Sheriff, met with the board and reported that there are 12 males and 2 females in the Fall River County Jail and 1 male in the Pennington County Jail, for a total of 15 inmates.

Evans spoke again of not receiving the LE vehicle ordered for the year and discussed options. Motion made by Russell, seconded by Allen, to approve allowing the sheriff to order a vehicle off state bid for 2022 now, to help alleviate vehicle wait time. With Cope voting no, all others voting yes, motion carries.

Stacey Martin, FR County GIS, met with the board. Motion made by Allen, seconded by Greenough, to approve the ESRI Quote for ArcGIS Primary Maintenance, in the amount of \$3,900.00.

Martin also updated the board that there are 101 new address requests, 64 address installations, and 11 new road names.

Susie Hayes, Director of Equalization, met with the board. Motion made by Greenough, seconded by Cope, to approve setting a hearing on October 7, 2021 at 9:35 a.m. for tax deed properties and properties going from exempt to taxable add-on for pay 2022.

Hayes updated the board that the upcoming Director of Equalization training. It will have some live and some virtual training, due to Covid and lack of staff at the Ramkota. DOE has done some bunker inspections at Igloo; and Hayes and Martin got to speak at the Stockgrowers's Convention, but not at the SD Counties Fall Convention.

Pat Ginsbach, Attorney for Todd Wynia and siblings, met with the board. Motion made by Russell, seconded by Greenough, to approve setting a hearing for vacating a portion of a section line adjacent to the Wynia property, on October 21, 2021 at 9:35 a.m.

The hearing for an Off-Sale Liquor License at Angostura Den, Inc. was held as advertised. Motion made by Cope, seconded by Russell, to approve the Off-Sale Liquor License at Angostura Den, Inc.

Randy Seiler, Highway Superintendent, met with the board. Motion made by Russell, to approve the Highway Department Safety Manual. Russell withdrew her motion to allow State's Attorney Russell a chance to review the manual.

Motion made by Russell, seconded by Allen, to approve the August 2021 reimbursement to the highway department for fuel used or work performed as follows: Sheriff's Department for \$2,929.61; Weed and Pest Office for \$760.64; Building for \$46.08; Emergency Management for \$105.82; GIS for \$101.80; and DOE for \$39.92; and maintenance for Weed and Pest Office vehicles, in the amount of \$1,086.62.

Motion made by Allen, seconded by Russell, to approve purchasing a used 500-gallon propane tank from Hi-D-Way Oil and Gas, for the Ardmore Shop, in the amount of \$1,500.00.

The board reviewed the requested functional classification, and the letter of support from the City of Hot Springs for the revision. Motion made by Allen, seconded by Russell, to approve the following resolution:

FALL RIVER COUNTY RESOLUTION 2021-49 APPROVING THE SOUTH DAKOTA DEPARTMENT OF TRANSPORTATION PROPOSED FUNCTIONAL CLASSIFICATION

WHEREAS, there are identified specific types of roads and corresponding functions of those roads, some of which have not been updated for several years; and

WHEREAS, the Federal Highway Administration (FHWA), has prescribed rules governing the functional classification of roadways within Fall River County; and

WHEREAS, the South Dakota Department of Transportation (SDDOT) has verified all roadway mileage for Fall River County; and

WHEREAS, SDDOT has recommended that changes be made to specific roadways based upon functional classification standards as prescribed by FHWA.

NOW, THEREFORE, BE IT RESOLVED, that the Board of County Commissioners hereby approve changing the following functional classifications in Fall River County:

Rural Minor Arterial to a Rural Major Collector

University Ave: From the intersection of US 18 east approximately 1.013 miles to the intersection of US 385/N. Chicago St.

Seiler updated the board that the Freightliner bid was reviewed by the State's Attorney with no issues.

Motion made by Greenough, seconded by Allen, to approve the pipeline easement between Fall River County and Timothy Allen and Lori Allen, 11086 Burlington Dam Road, Edgemont, SD, contingent on Timothy Allen's signature.

Motion made by Russell, seconded by Allen, to approve travel for Seiler to attend the Region 8 LTAP Conference in Sioux Falls, October 19 through October 21, 2021. The board asked that Seiler follow up with a report after the conference.

Seiler updated the board on the Rural Access Infrastructure Inventory to be done by May 2022, with the state providing \$40,000.00 for the project, to be used on secondary or township roads. Brosz can do the inventory for around \$38,000.00. The board asked that Seiler bring it back to the next meeting, with the possibility of getting more than one bid or quote.

Seiler stated that the company will be out to start grinding the road surface at Shep's Canyon averaging a mile per day and should take around 6 days. The board discussed the width of the road, agreeing on 23' wide; this should support the amount of traffic and keep the speed limits down. Seiler also stated that they are about halfway done with the mowing project.

Jerry Heiser and David Pabst, Butler Cat Machinery, met with the board, for the possibility of purchasing a new 2022 Butler Cat Road Grader next year. Butler will help with training on machinery. Motion made by Russell, seconded by Allen, to purchase a 2022 150-15AWD Motor

Grader, stock number M030588, in the amount of \$337,161.00, with a 7 year or 7,000-hour buyback/trade value. With Cope and Greenough voting no, all others voting yes, by roll call vote, motion carries.

The board will surplus an older grader at the next meeting.

Discussion was held on possibly more work done on the road to Igloo and putting more gravel down where needed; the board also discussed working overtime on getting roads graded when there was moisture.
