

FALL RIVER COUNTY WEED & PEST BOARD MEETING

January 6, 2022 Minutes

The Fall River County Weed and Pest Board meeting was called to order by President Jerry Wyatt at 2:07 PM January 6, 2022 at the Fall River County South Annex meeting room. Attending members were Joe Falkenburg, Bob Novotny, John Sides, Wayne Hageman, Telca Paprocki, Buffalo Gap Grasslands Rep., and Nina Steinmetz. All motions unanimous unless otherwise stated. Motion to approve the agenda and minutes of the last meeting were made by John Sides and seconded by Joe Falkenburg.

Old Business:

Nina S. reported that we are still waiting on approval from the SD weed and Pest Commission on two grants submitted.

New Business:

Nina Steinmetz presented an end of the year 2021 report and update on 2022.

Joe Falkenburg made a motion to retain the 2021 officers for 2022 and Bob Novotny seconded the motion. Officers are as follows: Jerry Wyatt, President, John Sides, Vice-President, Nina Steinmetz, Secretary.

John Sides made the motion and was seconded by Wayne Hageman, to approve the 2022 FRC Contract Spraying Rates: (Plus Chemical Costs) Government contracts - \$65/hour; Private Landowner w/ verification of need form - \$80/hour (Application costs will not qualify for reimbursements by government funded grant programs); Mosquito Fogging (towns only)- \$67/hour; Enforcement rate – Commercial rate time 2/hour; PERC (prairie dogs/moles/gophers) - \$50/hour; Lease to use ATV Prairie Dog Baiter - \$20/hour + \$200 deposit; Grasshopper Sprayer- County staff, \$67/hour, lease, \$30/hour - \$150/day + \$200 deposit; ATV spray unit - \$10 hr/\$50 day + \$200 deposit; Prairie Dog Applications – site visit - \$50 Pesticide- price subject to change.

- Supervisor Recertification class are being held on-line- cost for all classes and licenses, \$142.76
