The Fall River Board of County Commissioners met in regular session on June 23, 2022. Present: Joe Allen, Les Cope, Joe Falkenburg, Deb Russell and Sue Ganje, Auditor. Heath Greenough was absent.

The Pledge of Allegiance was given, and the meeting called to order at 9:00 a.m.

The Board reviewed a letter drafted by Chairman Falkenburg. Motion made by Cope, seconded by Allen, to approve the America the Beautiful letter and authorize the Chairman to sign.

Motion made by Russell, seconded by Allen, to surplus to junk an air conditioner, #01179, Clerk of Courts.

Motion made by Russell, seconded by Cope, to set a supplement and contingency transfer hearing for July 7, 2022 at 9:30 a.m.

There were no applicants for county assistance.

Bob Evans, Sheriff, reported to the Board that Attorney General's Official Opinion N0. 97-03 determines the arresting officer should be the party responsible for transporting individuals. Currently the Sheriff's Department has been transporting individuals for other entities but would like the Board to support a change to transport by the requesting officer and start charging entities that are unable to do their own transports. The County may still be responsible to transport juveniles. The Board agreed to the change to follow the AG's opinion, and recommended the Sheriff speak with the other entities about a charge for transports in the future.

Evans also discussed the need for hospitals or clinics to attempt to bill an individual's insurance prior to billing the county, and to include a denial from the insurance carrier, as per SDCL 24-11-21.1.

Evans reported that there are 12 males and 6 females in Fall River County, with 3 males and 1 female in Pennington County, for a total of 22 inmates.

Lily Heidebrink, Director of Equalization, met with the Board. Motion made by Russell, seconded by Cope, to approve hiring Carly Weishaupl–Freitag, \$13.00 per hour, effective July 5, 2022, as per union contract.

Heidebrink presented her 2023 budget and updated the Board that after reviewing certain codified laws, the Director of Equalization office will start valuing properties at whatever level of completion as of the November 1 assessment date each year, rather than waiting until buildings are at 50% completion.

Dave Weishaupl, Building Supervisor, presented his 2023 budget. Discussion was held on the white Durango; the Board asked Weishaupl to check for needed repairs and provide an estimate at a future meeting.

Liz Allen, Coroner, presented her 2023 budget.

Teresa Pullen, Treasurer, reported to the Board that at the end of January there will be 15 properties for the next tax deed auction. The Treasurer's office is currently working on 32 properties. Two properties may involve evictions, one in Edgemont and one in Hot Springs. Notice(s) to Quit will be served and may involve court action if needed.

Pullen presented her 2023 budget.

Brett Blessing, Highway Department, met with the Board and presented fuel quotes as follows:

Motion made by Russell, seconded by Allen, to approve the low and only bid from Nelson's for 8,000 gallons of diesel #2 at \$4.25 per gallon, for a total of \$34,000.00.

Motion made by Allen, seconded by Russell, to approve the May 2022 transfers to reimburse the Highway Department for fuel used or work performed as follows: Sheriff's Department for \$4,584.30; Weed and Pest Office for \$691.30; Emergency Management for \$153.66; Election for \$64.13 and Commissioners for \$14.73.

Discussion was held on Shep's Canyon Road with Jeanine Lecy commenting on the Game Fish & Park's heavy truck traffic, her request for additional speed limit signs, and noted improvements being made by the state with parking lots and camp sites. There are 129 homes on the road, all other traffic is Game, Fish and Park traffic. Falkenburg will contact the Sheriff to request more frequent patrols on the road, and the County will ask the State for an electric speed monitor. Blessing advised that the Base One project should start July 15, 2022.

Dustin Ross, Andersen Engineers, met with the board. Motion made by Allen, seconded by Russell, to approve the following resolution:

Joe Allen, Commissioner, reported to the Board that the flood plain issue needs to be resolved on the site of the proposed justice center by working with the City of Hot Springs and Corp of Engineers. The proposed trade of buildings (Tanner building and the County storage building) may not be possible with the area being zoned as residential. Allen noted that Black Hills Meat Company will have access from the north, Discussion was also on Allen and Cope meeting with Tobin Morris of Colliers Securities LLC on financing options. The Board would like to give the Heidebrinks a definite answer on the purchase of their properties within the next two weeks.

Les Cope, Commissioner, reported to the Board on the Black Hills National Forest Plan Revision Draft and that comments will be accepted for the next 45 days. A coalition meeting was recently held with Pennington, Meade, Custer, Lawrence and Fall River counties. Each county will have their own specific categories to research and comment on. Cope will be working with Frank Maynard, Emergency Management, Lance Russell, State's Attorney, and Nina Steinmetz, Weed and Pest for assistance with Fall River County's categories.
