The Pledge of Allegiance was given, and the meeting was called to order at 9:00 a.m.

The agenda was reviewed for conflicts; none were noted. ALL MOTIONS RECORDED IN THESE MINUTES WERE PASSED BY UNANIMOUS VOTE, UNLESS OTHERWISE STATED. Motion made by Russell, seconded by Greenough, to approve the agenda with the addition of discussion and possible action on providing a Holiday/End of the Year bonus.

Motion made by Russell, seconded by Allen, to approve the minutes of the County Commissioners for December 7, 2023.

Motion made by Russell, seconded by Greenough, to approve the Auditor's Account with the Treasurer for November 2023.

Motion made by Russell, seconded by Allen, to reset the Minimum/No Maintenance Road Hearing from January 4, 2024, to January 18, 2024 at 9:30 a.m.

Motion made by Greenough, seconded by Russell to set a Supplement and Contingency Hearing for December 28, 2023, at 9:30 a.m.

Motion made by Allen, seconded by Russell, to approve the pay increase for Jailer Hayley Rough Surface from \$19.75/hr to \$21.00/hr plus 2-year longevity of \$25.00/month, effective 12/14/2023; Maintenance Wesley Wood from \$18.50/hr to \$19.25/hr, effective 12/21/2023; and Heavy Equipment Operator Cory Amthor from \$21.00/hr to \$21.75/hr, effective 12/27/2023; all as per Union Contract.

Sheriff Lyle Norton, met with the Board to request approval for two items and to give the jail count as follows: The jail population for 2023 was 6,663 (which averages to be 18.25 inmates per day) and to provide the following current jail count of 8 inmates, 6 male and 2 females.

Motion made by Russell, seconded by Allen, to authorize Sheriff Norton to sign the 2024 Prisoner Housing Contract with Pennington County with the daily per inmate amount of \$95.00/day with special management daily amount of \$120.00/day.

Frank Maynard, Emergency Manager, met with the Board to discuss the location of the South Radio Repeater installation and go over the coverage maps that included the Eckard Well site and Oelrichs water tower site. He then provided updates that included Fires and Incidents.


