Lyle Norton, Sheriff, met with the Board for various items. He reported the jail census, 15 males and 4 females for a total of 19 in house with 1 female in Pennington County.

Motion made by Allen, seconded by Russell, to approve the quote from Axon Enterprise, Inc to

purchase 8 body-worn camera packages (including cloud storage, accessories and warranties) in the amount of 61,196.70 over the next 5 years (2024 - 12,239.34, 2025 - 12,239.34, 2026 - 12,239.34, 2027 - 12,239.34, 2028 - 12,239.34). Roll call was taken. With Cope voting no, all others voting yes, motion carried.

Motion made by Russell, seconded by Greenough, to approve travel for Sheriff Norton to attend the Police Chiefs' & Sheriffs' Spring Conference April 16-18, 2024 in Deadwood, SD at a cost of \$79.00 per night plus per diem.

Motion made by Russell, seconded by Allen, to approve travel for Deputy Dobbs and Deputy Wilson to attend the SD Network Against Family Violence & Sexual Assault (SVI) Training in Rapid City March 26 & 27, 2024 in Rapid City, SD at no charge for the class, per diem only.

Frank Maynard, Emergency Manager, met with the Board to provide updates. He reported that Gary Baker, Assistant Emergency Manager attended the tabletop exercise that was provided by the Bureau of Reclamation/Corp of Engineers. He informed the Board that he will be on vacation from March 27 through April 4, 2024. Fires and incidents were reported.

Joe Allen, Commissioner, met with the Board to provide his updates on the Justice Center/Jail plans that he has been working on with Elevatus.

The Minimum Maintenance Road Hearing took place as advertised with Brett Blessing, Highway Foreman, presenting each potential resolution.

Motion made by Russell, seconded by Allen, that the Unnamed Road (County Road 79J) in Township Ten (10) South, Range Seven (7) East of the Black Hills Meridian starting at the intersection with US Highway 18/385 then northwesterly a distance of approximately 1000 feet to the section line between Section one (1) and Section Two (2) in said Township and Range, then north along said section line approximately 700 feet is to remain designated as a Secondary Road.

Motion made by Allen, seconded by Greenough, that South Fork Road (County Road 1F) in Township Ten (10) South, Range Eight (8) East of the Black Hills Meridian starting at the intersection with US Highway 18 then south along the section line between Section Thirteen (13) and Section Fourteen (14) for a distance of three-fourths (3/4) of a mile in said Township and Range is to remain designated as a Secondary Road.

Motion made by Russell, seconded by Greenough, that Antelope Lane (County Road 4A) in Township Ten (10) South, Range Eight (8) East of the Black Hills Meridian starting at the intersection with old Highway 79 then east along the section line between Section Nineteen (19) and Section Thirty (30) for approximately one-fourth (1/4) of a mile in said Township and Range is to remain designated as a Secondary Road.

Motion made by Russell, seconded by Allen, that the Unnamed Road in Township Ten (10) South, Range Seven (7) East of the Black Hills Meridian starting at the intersection with Antelope Road (County Road 4A) then south along the west quarter-quarter line of Section Twenty-six (26) for a distance of threefourths (3/4) of a mile in said Township and Range is to now be designated as a Secondary Road.

Motion made by Greenough, seconded by Cope, that Wilcox Road (County Road 385D) in Township Eleven (11) South, Range Eight (8) East of the Black Hills Meridian starting at the intersection with US Highway 385 then east along the section line between Section Seven (7) and Section Eighteen (18) for a distance of approximately one-fourth (1/4) of a mile in said Township and Range is to be changed from a Minimum Maintenance designation to a Secondary Road designation on . Roll call was taken, with all voting yes, motion carried.

Motion made by Greenough, seconded by Russell, that Shirk Creek Road (County Road 385B) in Township Eleven (11) South, Range Seven (7) East of the Black Hills Meridian starting at the intersection with US Highway 385 then west on a line running parallel to the section line between Section Twelve (12) and Section Thirteen (13) at an offset of approximately 900 feet to the south. Total length of road approximately 2000 feet is to now be designated as a Secondary Road. With Cope abstaining, all others voting yes, motion carried.

Motion made by Cope, seconded by Allen, that the Unnamed Road in Township Twelve (12) South, Range Eight (8) East of the Black Hills Meridian starting at the intersection with Pleasant Ridge Road (County Road 385E) then south along the section line between Section Three (3) and Section Four (4) for a distance of approximately one half (1/2) mile in said Township and Range is to remain designated as a Secondary Road.

Motion made by Allen, seconded by Greenough, that the Unnamed Road (County Road 5C) in Township Twelve (12) South, Range Six (6) East of the Black Hills Meridian starting at the intersection with East Ardmore Road (County Road 5) then south along the section line between Section Ten (10) and Section Eleven (11) for a distance of approximately three-fourths (3/4) of a mile in said Township and Range is to remain designated as a Secondary Road.

Motion made by Russell, seconded by Cope, that Short Grass Road (County Road 2L) between Township Nine (9) South, Range Eight (8) East and Township Ten (10) South, Range Eight (8) East of the Black Hills Meridian starting at the intersection of North Butte Road (County Road 2) then east one half (1/2) mile on the township line between Section Thirty-two (32) of Township Nine (9) South Range Eight (8) East and Section Five (5) of Township Ten (10) South Range Eight (8) East to the end of the road in said Townships and Range is to remain as a Secondary Road.

Janelle Fink, Survey Department Manager of Advanced Design Engineering & Surveying, met with the Board to submit a petition to vacate a portion of a section line ROW.

Motion made by Greenough, seconded by Russell, to accept the petition for vacation of Section line Right-of-Way in Davis Subdivision and set the hearing for April 18, 2024 at 10:00 a.m.

Break was taken at 9:56 a.m. The meeting resumed at 10:03 a.m.

Public comment was heard. Jeanine Lecy, County resident talked about the potential issues that she believes will arise by the subdivisions that are being built in the Shep's Canyon area with the condition of the road. Paul Nabholz, County resident, presented a letter to the Board outlining his thoughts regarding the proposed Justice Center. Kelly Cape, representing the Minnekahta Fire Department, reported that they have been operating under 2 different names. The State of South Dakota doesn't have them listed as Minnekahta Fire Protection District, which is what they would like to remain using. It was discussed that a new resolution would need to be drawn up and approved by the Commission and submit it to the State. John Beard, County resident, conveyed to the Board that, if the current County jail is operable, we should just continue to use it and not build. Diane Newham, County resident, voiced her concerns regarding Igloo Road. She plans on circulating a petition to form a road district. Joe Messinio, County resident and part of the Town Board of Oelrichs, spoke in favor of building a new Justice Center.

Brett Blessing, Highway Foreman, came back to the Board with fuel quotes for 8,000 gallons of Dyed Diesel (50/50 winter blend) as follows: Vollan Oil, \$3.12/gallon; Nelson's Oil & Gas, \$3.32/gallon; MG Oil, no bid. He also presented Beadle County culvert bids, an agreement with the State of SD for striping roads, present an approach permit for Akeem and Stephani Lucey and discuss 2 permits to occupy County Right-of-Way from Golden West Telecommunications, and to provide updates.

Motion made by Cope, seconded by Russell, to accept the low bid from Vollan Oil in the amount \$3.12/gallon for 8,000 gallons of Dyed Diesel (50/50).

Motion made by Allen, seconded by Russell, to approve accepting Beadle County's culvert bids to

purchase off of.

Motion made by Russell, seconded by Greenough, to approve the State of SD Department of Transportation Joint Powers agreement to provide for the pavement of County Roads within Fall River County and authorize the Chairman to sign.

Motion made by Russell, seconded by Greenough, to approve and authorize the Chairman to sign the Approach Permit for Akeem and Stephani Lucey on the west side of Old Hwy 79 approximately 1 mile north of Maitland Rd.

Motion made by Russell, to approve the Permit to Occupy the County Highway Right-of-Way from Golden West Telecommunications in the areas of Hot Springs, Hot Springs NE and Minnekahta NE. Motion died for lack of a second due to the Highway Department needing to review both permits.

Motion made by Greenough, seconded by Cope, to bring the 2 Golden West Telecommunications Permits to Occupy County Highway Right-of-Way to the next meeting.

Blessing went on to report that they have moved equipment out of the Simons Pit.

Commission Chairman Falkenburg declared the meeting adjourned at 10:46 a.m.
