FALL RIVER COUNTY UNAPPROVED MINUTES OF APRIL 18, 2024

The Fall River Board of County Commissioners met in regular session on April 18, 2024. Present: Joe Allen, Les Cope, Joe Falkenburg, Deb Russell and Sue Ganje, Auditor. Heath Greenough was absent.

The Pledge of Allegiance was given, and the meeting was called to order at 9:00 a.m.

The agenda was reviewed for conflicts; none were noted. ALL MOTIONS RECORDED IN THESE MINUTES WERE PASSED BY UNANIMOUS VOTE, UNLESS OTHERWISE STATED. Motion made by Russell seconded by Allen, to approve the agenda with the change of Les Madsen speaking at 9:45 a.m. and the hearing for vacation of Section Line Right-of-Way in Davis Subdivision occurring at 10:00 a.m. Also, the addition of an emergency action to close the Courthouse and Director of Equalization Office on Tuesday, April 23, 2024, due to the road construction replacement of the water main.

Motion made by Russell, seconded by Allen, to approve the meeting minutes from April 4, 2024.

Motion made by Greenough, seconded by Russell, to approve the Auditor's Account with the Treasurer for March 2024.

Motion made by Russell, seconded by Greenough, to approve pay increases for Charles Dobbs, Sheriff Deputy, from \$24.75/hr to \$26.00/hr, plus \$25.00/month longevity, effective 04/21/2024 and for Lynn Two Bear, State's Attorney Legal Assistant, \$50.00/month longevity, effective 04/21/2024.

Motion made by Greenough, seconded by Allen, to approve travel for Teresa Pullen, Treasurer, Melody Engebretson, Register of Deeds, and Stacy Schmidt, Deputy Auditor to attend the SDACO Spring Workshop in Pierre on May 15 & 16, 2024.

Motion made by Russell, seconded by Greenough, to appoint Stephen Heimgartner as Deputy Coroner and to remove Bob Evans and Jordan Hanson (Stevens) as Deputy Coroners.

There were no County Assistance applications.

Frank Maynard, Emergency Manager, met with the Board. Updates were given regarding the road construction.

Motion made by Russell, seconded by Cope, to approve and authorize the Chairman to sign the LEMPG 2nd Quarter Single Signature Form.

He informed the Board that Gary Baker, Assistant Emergency Manager and Anna Maciejewski, Highway Office Manager will be attending the Crisis Track Training in Rapid City on May 23, 2024.

Motion made by Russell, seconded by Cope, for an emergency action of Courthouse and Director of Equalization Office closure on Tuesday, April 23, 2024, due to the road construction water main replacement, causing the water line to be inoperable.

Isnalawica Belt, Chief Deputy Sheriff, met with the Board for various items The jail census was given as follows: 11 males and 3 females in house, with 2 females in Pennington County and 1 female in Meade County. He also informed the Board that the Sheriff's Department had set up an agreement with

Winner, SD in case the water/sewer construction took longer than expected, for inmate housing.

Motion made by Greenough, seconded by Allen, to approve travel for Deputy Blaine Wilson to attend Criminal Interdiction training at the Pennington County Sheriff's Office May 21 through May 23, 2024 paying per diem only.

Motion made by Greenough, seconded by Russell, to approve and authorize the Chairman to sign the 2024 USFS Cooperative Agreement (Keith Park, Cascade Falls, and Antelope patrol). The agreement authorizes USFS to pay Fall River County \$7,200.00.

Motion made by Greenough, seconded by Russell, to approve hiring Meghan Swaney-Boschetti as an Uncertified Dispatcher at \$18.50/hr, effective 04/22/2024.

Motion made by Greenough, seconded by Allen, to approve hiring Michael Close as a Certified Deputy at \$24.50/hr, effective 04/22/2024.

Break was taken at 10:05 a.m. The meeting resumed at 10:14 a.m.

Public comment was heard at this time. Susan Henderson, County resident, let the Board know that there was information sent out from the Army Corps of Engineers regarding the former Black Hills Ordinance Depot information. She wanted to warn every one of the dangers of buried munitions, etc. The public can visit the US Army Corps of Engineers website for further information. She also questioned the Board regarding the proposed Justice Center and current jail. Sue Ganje, Auditor, informed the Board that she will be bringing a Road District formation petition to the next meeting to set a meeting date for the election. Joe Falkenburg, Chairman, informed the Board that he wanted to bring awareness to June as Men's Health Month and will have a proclamation regarding it at a future meeting.

Dave Weishaupl, Maintenance Supervisor, met with the Board to present a quote from Golden West Technologies for internet switches.

Motion made by Cope, seconded by Russell, to approve Golden West Technologies quote for Ruckus ICX 1750-C1OP, Ruckus ICX 1750 Switch, Ruckus ICX7150-48PF Switch, Ruckus Watchdog Remote Support, Slim Patch 7 ft cables, and project installation and configuration in the amount of \$12,209.14.

Joe Allen, Commissioner, provided his report to the Board regarding the proposed Justice Center/Jail. He has been working on collecting information, regarding the property that is East of the Courthouse and current jail. He asked that the Board consider some items that need to be addressed immediately regarding propane lines and water lines, due to the construction of the highway.

Motion made by Russell, seconded by Cope, to approve the installation of a water line sufficient for a larger facility and a propane line under the highway that will cost approximately \$2,500.00.

Motion made by Russell, seconded by Greenough, to enter executive session to discuss personnel and legal, as per SDCL 1-25-2 (1) and (3) at 10:47 a.m.

The Board came out of executive session at 11:00 a.m.

Motion made by Russell, seconded by Allen, to increase Brett Blessing's wages by \$1,000.00 per month, beginning April 1, 2024 until a new Highway Superintendent has been hired.
