The Fall River Board of County Commissioners met in regular session on January 2, 2025. Present: Joe Allen, Les Cope, Joe Falkenburg, Deb Russell, Sandra Wahlert and Sue Ganje, Auditor.

An invocation was provided by Wahlert, the Pledge of Allegiance was given, and the meeting was called to order at 9:00 a.m.

The agenda was reviewed for conflicts; none were noted. ALL MOTIONS RECORDED IN THESE MINUTES WERE PASSED BY UNANIMOUS VOTE, UNLESS OTHERWISE STATED. Motion made by Allen, seconded by Falkenburg for nominations to cease. Russell will remain as the Vice-Chair for 2025.

The Board reviewed the remainder of the items on the list to approve.

Motion made by Allen, seconded by Cope, to approve the consent agenda Fourth grouping to include the following: to set the chairman of the mental health board's fee of \$150.00 per hour; to not rehire any employee who is eligible for and has retirement funds withheld, for a period of 6 months, if that employee has resigned and withdrawn their SD Retirement Funds, unless specifically authorized by the Board; and to appoint Stacey Martin as PIO (Public Information Officer), with Melissa Fleming and Bobbie Janis as assistants.

There were no County assistance/death expense applications.

Lyle Norton, Sheriff, met with the Board to provide updates and the jail census of 22 inmates. With 15 male and 6 female in house and 1 male in Meade County. Falkenburg expressed his appreciation of our

local law enforcement.

Motion made by Russell, seconded by Wahlert, to approve Tina Norton as the Jail Contract Nurse with a raise of the contracted monthly amount from \$1,250.00 to \$1,500.00.

Motion made by Russell, seconded by Allen, to approve hiring Anthony Otteson as a jailer at \$24.50/hr, effective 01/12/2024.

Motion made by Wahlert, seconded by Russell, to approve renewing the Maintenance & Support Agreement for the Idemia LiveScan finger printing machine at a cost of \$2,536.00 for February 2025-February 2026.

Motion made by Russell, seconded by Allen, to approve the purchase of a wall split heating/cooling unit from Nelson's Oil & Gas for the 911 Dispatch Center server/radio room climate control at a cost of \$5,500.00 for the unit and installation.

Tony March, Highway Superintendent, met with the Board to present 2 Right-of-Way occupancy requests, to request a private road work hearing and provide updates. He wanted the Board to know that he had spoken with the Irrigation District and made an agreement with them. The County can plug the blade in that is stationed near them at their shop in exchange for minimal blading on their road. He reported that he had also talked with Scott Harkless of Golden West Telecommunications and Scott had agreed to take a look at the area by the County Storage Building that is being proposed as a new entrance location for a driveway and will report back. March also wanted to report that he has witnessed quite a few large trucks seemingly going quite fast on the Smithwick Road and that contributes to the deterioration of the road.

Motion made by Allen, seconded by Russell, to approve both of Golden West Telecommunication's applications for permit to occupy County Right-of-Way as follows: located at an existing vault in the south ROW line of Indian Canyon Rd to the west side of the driveway road to 11774 Indian Canyon Rd; and located at an existing vault in the north ROW line of Hot Brook Canyon Rd approx. 2 miles west of Hot Springs to a residence at 12570 Hot Brook Canyon Rd.

Motion made by Cope, seconded by Russell, to set a private road work hearing for February 6, 2025 at 9:30 a.m. as per SDCL 31-11-41 through 31-11-45.

Public Comment was heard at this time. Genevieve Osborn and Jana Doering of Addiction Recovery Center of the Black Hills asked the Board for a letter of support for their organization to apply for a grant through the State of South Dakota for Opioid funding. They provided a brief explanation of what they do for the local community.

Motion made by Russell, seconded by Wahlert, to provide a letter of support for the Addiction Recovery Center of the Black Hills and authorize the Chairman to sign.

Dar Coy, Emergency Manager, met with the Board. He provided updates and reported on incidents. He asked the Board to keep Gary Baker, Assistant Emergency Manager, for a while longer. They are currently working on a hazard mitigation training.

Joe Allen, Commissioner, had nothing new to report on the proposed Jail/Justice Center.

Motion made by Russell, seconded by Cope, to note that January 9, 2025 is National Law Enforcement Appreciation Day. The County would like to express its appreciation for local Law

Enforcement.

Motion made by Allen, seconded by Wahlert to approve the bills paid in between meetings, these bills were included in the December 19, 2024 minutes.

Break was taken at 9:50 a.m. The meeting resumed at 9:55 a.m.

Motion made by Russell, seconded by Cope, to enter into Executive Session for personnel as per SDCL 1-25-2 (1) at 9:57 a.m.

Falkenburg declared the Board out of Executive Session at 10:21 a.m. No action was taken.

Falkenburg then declared the meeting adjourned at 10:22 a.m.
