FALL RIVER COUNTY UNAPPROVED MINUTES OF APRIL 3, 2025

The Fall River Board of County Commissioners met in regular session on March 20, 2025. Present: Joe Allen, Les Cope, Joe Falkenburg, Deb Russell and Sue Ganje, Auditor. Sandra Wahlert was absent.

An invocation was given by Russell.

The Pledge of Allegiance was given, and the meeting was called to order at 9:00 a.m.

The agenda was reviewed for conflicts; none were noted. ALL MOTIONS RECORDED IN THESE MINUTES WERE PASSED BY UNANIMOUS VOTE, UNLESS OTHERWISE STATED. Motion made by Russell, seconded by Allen, to approve the agenda with the addition of hire approval for 2 Dispatchers and a Resolution requesting the Black Hills National Forest Service restore funding for invasive weed management on the Black Hills National Forest.

Motion made by Russell, seconded by Allen, to approve the meeting minutes from March 20, 2025.

Motion made by Allen, seconded by Russell, to surplus to junk an HP PSC 1410 All-in-one printer, asset tag #1985 and an HP Envy 4500 printer, asset tag #01993 from the Weed & Pest Department.

There were no County assistance applications.

Dar Coy, Emergency Manager, met with the Board.

Motion made by Russell, seconded by Allen, to approve the 2nd Quarter LEMPG Single Signature Sheet and authorize the Chairman to sign.

Coy then provided updates and reported on incidents. He stated that the Homeland Security meeting had been cancelled. He reminded the Board that County employees will need to take the Defensive Driving Course on May 13, 2025. There are 2 sessions, 10:00 am and 1:00 pm to accommodate all staff to attend. He also let everyone know that there will be a meeting on May 2, 2025, 11:00 am at the Mueller Center with Black Hills Energy to discuss the possibilities of shutting down power during hot windy days due to the risk of fires.

Lyle Norton, Sheriff, met with the Board. Falkenburg thanked Norton for getting the surplus vehicles out of the north parking lot.

Motion made by Allen, seconded by Russell to approve Fall River County Resolution #2025-10 as follows:

FALL RIVER COUNTY RESOLUTION #2025-10 DECLARING APRIL 13 – 19, 2025 NATIONAL PUBLIC SAFETY TELECOMMUNICATORS WEEK

WHEREAS, emergencies can occur at any time that require law enforcement, fire, or emergency medical services; and,

WHEREAS, when an emergency occurs the prompt response of law enforcement officers, firefighters, and EMS providers is critical to the protection of life and preservation of property; and,

WHEREAS, the safety of our law enforcement officers, firefighters, and EMS providers is dependent upon the quality and accuracy of information obtained from citizens who contact the Fall River County 911 Dispatch Center; and,

WHEREAS, Public Safety Telecommunicators are the first and most critical contact our citizens have with emergency services; and,

WHEREAS, Public Safety Telecommunicators are the single vital link for our law enforcement officers, firefighters, and EMS providers by monitoring their activities by radio, providing them information, and ensuring their safety; and,

WHEREAS, Public Safety Telecommunicators are critical in improving the chance of survival for patients who experience sudden cardiac arrest by recognizing the need for cardiopulmonary resuscitation and other lifesaving interventions prior to arrival of EMS; and,

WHEREAS, Public Safety Telecommunicators of the Fall River County 911 Dispatch Center has contributed substantially to the apprehension of criminals, suppression of fires, and treatment of patients; and,

WHEREAS, each telecommunicator has exhibited compassion, understanding, and professionalism during the performance of their job in the past year.

NOW, THEREFORE, BE IT RESOLVED that the Fall River County Commission declares the week of April 13 – 19, 2025 to be National Public Safety Telecommunicators Week in the County of Fall River, South Dakota in honor of the individuals whose diligence and professionalism keep our community and citizens safe.

Motion made by Russell, seconded by Allen, to approve hiring Gabrielle Gallegos as an Uncertified Dispatcher at \$19.50/hr, effective 03/16/2025.

Motion made by Allen, seconded by Russell, to approve hiring Laciana Bettelyoun as an Uncertified Dispatcher at \$20.50/hr, effective 04/01/2025. The higher rate is due to having some experience.

Russell inquired about providing exit interviews due to the Dispatch turnover rate. Norton responded that they fill out a questionnaire and have a short face-to-face meeting with exiting employees.

Motion made by Cope, seconded by Allen, to authorize replacing the transmission on 2020 Ford F-150 patrol vehicle, estimated to cost \$7,000.00.

Motion made by Russell, seconded by Allen, to approve moving one dispatch desk into the jail that is hardwired and will require the work to be done by an electrician and to have the electrician install a dedicated breaker for the body scanner at approximately \$500.00 to \$1,000.00.

Norton provided updates and the jail census of 11 males and 6 females in house, with 1 male in Meade County, for a total of 18 inmates.

Tony March, Highway Superintendent, met with the Board. He presented fuel quotes and various approach permit applications, highway right-of-way applications and pipeline easements.

The fuel quotes were as follows: Vollan Oil \$2.62/gal for 8,000 dyed diesel (50/50 Winter Blend); CBH Co-Op \$3.106/gal for 8,000 gallons of dyed diesel (50/50 Winter Blend); Nelson's Oil & Gas \$2.62/gal for 8,000 gallons of dyed diesel (50/50 Winter Blend); no bid from Hi-D-Way; and MG Oil declined to bid.

Motion made by Cope, seconded by Russell, to approve the low bid from Vollan Oil of \$2.62/gal for 8,000 gallons of dyed diesel (50/50 Winter Blend).

Motion made by Russell, seconded by Allen, to approve the application for permit to occupy County highway right-of-way from Golden West Telecommunications located from the west right-of-way line of Indian Canyon Rd north of SD Hwy 71/Cascade Rd to the east right-of-way line. Construction will consist of boring Indian Canyon Rd.

Motion made by Cope, seconded by Allen, to approve the application for road approach permit from Harley Miller on the north side of Rocky Ford Rd (County Rd #11S) at approximately SE1/4SW1/4 Sec 10 and NE1/4NW1/4 Sec 16, T9S, R4E, BHM, Fall River County, South Dakota.

Motion made by Cope, seconded by Allen, to approve both applications for road approach permits and for Fall River County Pipeline Easements as follows: From Robbie Bequin on the west side of Sunny Brook Rd north of US Hwy 18 at approximately .75 mile south of 28309 Sunny Brook Rd to serve a business; from Kerry D Barker on the north side of Old Hwy 18 at approximately 100' west of 28558 Old Hwy 18 to service a driveway; from Indian Creek Cattle, LLP to cross W Ardmore Rd near the SE1/4SE1/4, Sec 19, Twp 12S, R3E, BHM; from Indian Creek Cattle, LLP to cross Crow Dam Rd near SW1/4SE1/4, Sec 1, T11S, R3E, BHM; from Indian Creek Cattle, LLP to cross Rumford Cut Across Rd near NW1/4SW1/4SE1/4 Sec 31, T10S, R4E, BHM; from Indian Creek Cattle, LLP to cross Crow Dam Rd near SE1/4SE1/4 Sec 11, T11S, R3E, BHM, all in Fall River County, South Dakota.

Motion made by Allen, seconded by Cope, to approve the Notice of Award to Bituminous Paving, Inc for the 2025 Asphalt Surface Treatment Contract in the amount of \$263,633.80.

March then provided updates regarding work being performed.

Teresa Pullen, Treasurer, met with the Board.

Motion made by Allen, seconded by Russell, to approve advertising for a part-time employee (that will be funded by Oglala Lakota County).

Pullen then asked the Board about potentially writing off old County Liens that are 21–31 years old. Lance Russell, State's Attorney, advised that there are quite a few individuals with older liens that are

reoffending and adding to the amounts of the liens. He would like to think a little more about Court Appointed Attorney fees but agreed that older County Poor (Indigent Assistance) could be written off.

Motion made by Allen, seconded by Russell, to approve writing off County Poor (Indigent Assistance) that are 21 or more years old.

Joe Allen did not have any updates regarding the proposed Jail/Justice Center. The meeting with Johnson Construction Company, a potential contractor for the proposed Jail/Justice Center will be during the next Commission Meeting during the open session.

Motion made by Allen, seconded by Russell, to approve and authorize the Chairman to sign the 2025 MOU Addendum between SDSU and Fall River County.

Motion made by Russell, seconded by Allen, to approve and authorize the Chairman to sign the 2025 County Contract for Provision of Community Health Public Health Nursing Services.

Sue Ganje, Auditor, met with the Board.

Motion made by Allen, seconded by Russell, to rescind Fall River County Resolution #2021-51 due to it containing an incorrect legal description.

Motion made by Russell, seconded by Allen, to approve Fall River County Resolution #2025-11 as follows:

WHEREAS, on March 3, 2020, the Oelrichs Historical Society (Society) approved a formal request that Fall River County (County) transfer ownership of several tax deed properties to the Society, and

WHEREAS, The County deems it in the best interest of the public to convey the following described real property to the Society to be used by the Society for the benefit of the public as the Historical Society shall see fit in accordance with the law.

Break was taken at 10:05 a.m. The meeting resumed at 10:13 a.m.

Public comments were heard. Rheta Reagan, Mayor of Edgemont and County resident, thanked the Board for sending a letter in opposition of the proposed elimination of the Edgemont terminal. She reported that there are 27 Engineers and Conductors that live in Edgemont with many others living within the County. Sue Ganje, Auditor, informed the Board that she has been in contact with the SD Department of Revenue to get information regarding loss in taxes. She will gather information to write a letter to State and Federal Agencies to explain how detrimental that would affect the County. She will also follow up with the Governor of South Dakota. Susan Henderson, County resident, spoke regarding the plan of the National Weather Service to cut back on weather balloons in Nebraska. This will impact forecasts as well as weather warnings. Joe Falkenburg, Commission Chairman, relayed to the Board that Representative Trish Ladner does not support a 99-year loan to pay for the proposed Jail/Justice Center. Neil Miller, County resident, wanted to let the Board know that there will be a "Meet the Decision Makers" meeting with the Black Hills National Forest Service at Cascade Falls Park on April 26, 2025 from 1-4 p.m. to discuss what they can or can't do at our Fall River parks. Lastly, Everett Dossey from the Angostura Irrigation District came to discuss a possible MOU with the County for use of the Highway Department's equipment. He will speak with Tony March and Lance Russell to get something drawn up to present at a future meeting.

Stacey Martin, GIS Coordinator, met with the Board. She presented a report regarding new housing and new addresses. There have been 89 new buildings and addresses assigned with 21 more addresses without buildings assigned. She then presented a list of signs for replacement in 2025. Falkenburg noted that there are a lot of signs missing in the Edgemont area. Martin reported that many had been installed

without washers. She will compile a list and bring back a quote to replace them. Lastly, she spoke regarding a notification that she had received stating that Facebook would be deleting videos after 30 days. She asked the Board to think about what they would like to do regarding meeting video retention. She will do some more research to see if she can find a different way to retain older videos for the County website and report back at a later meeting.

Lily Heidebrink, Director of Equalization, met with the Board to ask for travel approval and discuss changing the date of the continuation of the Equalization Appeal meeting due to April 18th being Good Friday.

Motion made by Allen, seconded by Russell, to approve travel for Heidebrink and Heather Shaffer, Certified Assessor, to attend SDAAO School in Sioux Falls, September 14-19, 2025 to include registration fee, lodging and per diem.

Motion made by Russell, seconded by Cope, to approve conducting the continuation of the Equalization Appeal meeting on Tuesday, April 22, 2025 instead of Friday, April 18, 2025.

Sue Ganje, Auditor, continued with public comment. She read a statement that she had prepared, offering an apology and her gratitude to the staff of Fall River County for their patience and grace for the last few months during the transition into a new payroll software company. The first live payroll run had errors with pay type mapping which resulted in overpayments. She invited the Board and any employees to visit the office for a hands-on training of the new system and to answer any questions.

Nina Steinmetz, Weed and Pest Supervisor, requested the Board approve a resolution that some other counties have approved.

Motion made by Allen, Seconded by Russell, to approve Fall River County Resolution #2025-13 as follows:

FALL RIVER COUNTY RESOLUTION #2025-13

RESOLUTION REQUESTING THE BLACK HILLS NATIONAL FOREST SERVICE RESTORE FUNDING FOR INVASIVE WEED MANAGEMENT ON THE BLACK HILLS NATIONAL FOREST

WHEREAS, the Counties of Custer, Fall River, Lawrence, Meade, and Pennington, South Dakota and the Counties of Crook and Weston, Wyoming (Counties of the Black Hills National Forest) have deemed the management and control of invasive weeds a priority in protecting public health and safety, economy, property values, natural resources, and the productivity of our agricultural lands; and

WHEREAS, the States of South Dakota and Wyoming have State Statutes requiring the control of invasive weeds across all landownerships; and

WHEREAS, the policies of the United States of America are to prevent the introduction, establishment, and spread of invasive species, as well as to eradicate and control populations of invasive species that are established through their Laws, Acts, Statutes and Executive Orders; and

WHEREAS, the Biden Administration in December of 2024 removed all the Knutson-Vandenberg funding from the Black Hills National Forest to help pay for regional and national forest service personnel salaries. That funding is pivotal in the management of Invasive Weeds on the Black Hills National Forest; and

WHEREAS, the Forest Service has not adequately funded invasive weed management program on the Black Hills National Forest.

NOW THEREFORE BE IT RESOLVED:

- 1. The Counties of the Black Hills National Forest are calling for reinstatement of the Knutson-Vandenberg funds back to the Black Hills National Forests. Funds that were collected from timber sales sold on the Black Hills National Forest that are to be used to finance restoration work within those timber sale areas.
- 2. The Counties of the Black Hills National Forest are requesting the National Forest to adequately fund the invasive weed management program on the Black Hills National Forest. Including deeming the Black Hills Invasive Species Coordinator position as Essential Personnel within the Black Hills National Forest.
- 3. The Counties of the Black Hills National Forest are calling on the Forest Service to expedite the reinstatement of the Knutson-Vandenberg Funding back to the Black Hills National Forest and funding for the invasive weed management program.




FALL RIVER COUNTY HIGHWAY DEPARTMENT SPECIFICATIONS FOR COUNTY ROADS AND APPROACHES



The above Typical Road Section and Typical Approach Detail (below) shall be followed in the construction of roads to be placed on the County Road System. Road design shall be consistent with published Standards of the American Association of State Highway Transportation Officials. Road construction materials and methods shall conform to the current published edition the "Standard Specifications for Roads and Bridges" of the South Dakota Department of Transportation, when referenced in the Standards below. Copy of these Specifications is on file at the County Highway Department Office.

The following are standards which shall be met:

- 1. Maximum Grade of any road or portion of road shall not exceed ten percent (10%)
- 2. Maximum Degree of Curvature shall not exceed twenty one degrees (21 degrees)
- 3. Crown rates shall be between 0.02 11/11 to 0.06 11/11. Maximum Super elevation rate in curves shall be 0.07 11/11.
- 4. Culverts shall be sized to assure proper drainage. The minimum size of culvert shall be eighteen inches (18") in diameter. Although fifteen inch (15") diameter will be allowed under certain conditions.
- 5. Gravel Surfacing shall meet the requirements of Part B of the Standard Specifications.
- Asphalt and Concrete construction methods and materials shall meet the requirements of Part C and Part D of the "Standard Specifications".
- 7. All Dead-End Roads shall have Cul-De-Sacs with a minimum constructed radius of fifty feet (50').
- 8. Approaches shall be constructed perpendicular as practical to the County Road.
- 9. The Minimum dedicated Right-Of-Way width shall be sixty six feet (66").



TYPICAL APPROACH DETAIL

- 1. Only one approach shall be allowed to each tract or parcel of land.
- Existing roadway drainage will be maintained. Culverts shall be sized to assure proper drainage. The maximum size of
 culvert shall be eighteen Inches (18") in diameter, although fifteen Inch (15") diameter will be allowed under certain
 conditions. The minimum length of approach culvert shall be thirty-two feet (32")




Retail Liquor can sell liquor on-sale within city limits (Bars/Restaurants).

RB licensees can self malt beverages and SD made wine for on & off premises consumption.

Retail Restaurant licensees can sell malt beverages, wine and spirits (all alcoholic beverages) for on premises consumption. PL licensees can sell malt beverages, wine and spirits (all alcoholic beverages) for off premises consumption.

Liquor and wine licensees transporting their own product from wholesalers to their retail stores. Per Marnie at State of SD, this particular license was abolished during the 2018 legislative session. No longer needed - a store with a valid alcohol license can get their supplies either delivered or they can pick up, it is now part of the regular alcohol license Ţ

INSTRUCTIONS FOR COMPLETING THE APPLICATION

City & County Issued - New Licenses, Renewals & Transfers

A separate application is required for each license type.

Section A: Complete with the Corporation, LLC, Partnership, or Sole Proprietor's name, mailing address, and telephone number. If the owner is a Corporation or LLC, page 2 of the application must be completed.

Section B: Complete with the Doing Business As name, physical address, and telephone number.

Section C: Mark the type of license being applied for. If Other, enter the corresponding statute. All questions in this area must be completed. The licensee cannot have a felony on their record per SDCL 35-2-6.2.

Section D: Enter the legal description of the property to be licensed for alcoholic beverage sales. The legal address is not the street address.

Section E: Enter the sales tax license number for the business. **Remember that the sales tax license and the alcoholic beverage license must be in the same name.** A copy of the sales tax license may be submitted along with the application to ensure the licenses are in the same name. If the sales tax license has not yet been received but has been applied for, put "applied for" in this section. Note: the sales tax license number looks something like this: 1000-0000 ST.

Section F: Mark this as a new license, renewal, or transfer.

Section G: This is for the licensee's signature. The officer, member, or partner should sign for a Corporation, LLC, or Partnership. For city-owned/operating agreement licenses, the business owner should sign this section.

Section H: This section is for the local government to complete. A notice of hearing must be published in the local newspaper **at least seven days** before the hearing. After the application has been approved, the mayor signs this section, and the finance officer sends the paperwork to Pierre.

When DOR approves the license, we will issue a license number, renew, or transfer the license and send the license to the Finance Officer or County Auditor, who will send it on to the licensee.

Half of the malt beverage license fee and the application are sent to the Department of Revenue by the Finance Officer or County Auditor.



We appreciate the opportunity to present this proposal for structural engineering services for the repair of the exterior grand stairs at the Fall River County Courthouse located in Hot Springs, SD. Below is our understanding of the project:

PROJECT DESCRIPTION

The Fall River County Courthouse is a historic facility that consists of exterior stack stone walls and interior timber framing similar to several other buildings along North River Street in Hot Springs, SD. The exterior grand stairs provides access from the sidewalk to the main second floor of the building. These stairs consist of cast-in-place concrete treads with original inset steel nosing pieces. Most of the treads exhibit signs of concrete deterioration due to freeze-thaw damage, reinforcement corrosion, and concrete spalling. The extent of deterioration and spalling is such that the County is not allowing regular foot traffic on the stairs at this time. The stairs only appear to need to extensive surface level repairs. Based on an initial site visit by Albertson Engineering Inc. (AEI) they do not appear to exhibit signs of "global" failure which could result in collapse. The existing guardrail/handrail assembly also needs to be replaced as signs of corrosion are present throughout these steel members.

The County is interested to have the stairs repaired and the handrail/guardrail replaced to allow normal pedestrian access on the stairs again.

Dear Ms. Ganje,

The payment for this solar farm is \$271,380.44. This is for the 2024 nameplate capacity tax and production tax payment from Fall River Solar. This is an alternative tax as defined in SDCL 10-35-17. I have included a copy of this statute.

Alternative annual tax on wind farm property and solar facilities.

Any company owning or holding under lease, or otherwise, real or personal property used, or intended for use, as a wind farm producing power for the first time after June 30, 2007, and before April 1, 2015, shall pay the alternative annual taxes provided in §§ 10-35-18 and 10-35-19. A wind farm that produces power for the first time after March 31, 2015, or a solar facility, shall pay the alternative annual taxes provided in §§ 10-35-18 and 10-35-19.1. The alternative taxes imposed by §§ 10-35-18, 10-35-19, and 10-35-19.1, are in lieu of all taxes levied by the state, counties, municipalities, school districts, or other political subdivisions of the state on the personal and real property of the company which is used or intended for use as a renewable facility, but are not in lieu of the retail sales and service tax imposed by chapter 10-45, the use tax imposed by chapter 10-46, or any other tax.

This money should be apportioned as defined in SDCL 10-35-21. I have included a copy of this statute too. I am also including a spreadsheet with our estimates for the affected taxing jurisdictions based on the apportionment defined in SDCL 10-35-21. However, you are responsible for the apportionment of taxes in your county and should only use this as a guide.

10-35-21. Distributions from wind energy tax fund. The secretary shall distribute all of the tax deposited in the wind energy tax fund pursuant to § 10-35-18 and twenty percent of the tax deposited in the wind energy tax fund pursuant to §§ 10-35-19 and 10-35-19.1 to the county treasurer where the wind farm is located. If a wind farm is located in more than one county, each county shall receive the same percentage of the tax as the percentage of wind towers in the wind farm located in the county. Upon receipt of the taxes, the county auditor shall apportion the tax among the school districts, the county, and the organized townships where a wind tower is located. The tax shall be apportioned by the county auditor by allocating fifty percent of the tax to the school district where each wind tower is located, fifteen percent to the organized township where each wind tower is located, and thirty-five percent to the county. If a wind tower is located in a township that is not organized, the unorganized township's share of the tax for that wind tower is allocated to the county. The secretary shall distribute the money to the counties on or before the first day of May. Any remaining revenue in the wind energy tax fund shall be deposited in the state general fund.
