FALL RIVER COUNTY UNAPPROVED MINUTES OF JULY 3, 2025

The Fall River Board of County Commissioners met in regular session on July 3, 2025. Present: Joe Allen, Les Cope, Joe Falkenburg, Deb Russell, Sandra Wahlert and Sue Ganje, Auditor.

An invocation was given by Wahlert.

The Pledge of Allegiance was given, and the meeting was called to order at 9:00 a.m.

The agenda was reviewed for conflicts; none were noted. ALL MOTIONS RECORDED IN THESE MINUTES WERE PASSED BY UNANIMOUS VOTE, UNLESS OTHERWISE STATED. Motion made by Russell, seconded by Wahlert, to approve the agenda, adding "possible action after the Pipeline Easement under the Highway Department.

Motion made by Russell, seconded by Wahlert, to approve the Fall River County Commission meeting minutes from June 19, 2025.

Motion made by Wahlert, seconded by Cope, to surplus a Shop-Vac that no longer works, asset tag #01917, from Building and Maintenance to junk.

Motion made by Russell, seconded by Wahlert, to surplus to sell a 2006 Kawasaki Mule and a 2009 Polaris Ranger due to not meeting the needs of the job from the Weed & Pest Department.

Motion made by Wahlert, seconded by Allen, to set the date and provide Notice of Surplus Property Sale for an on-line auction to begin on August 7, 2025 and remain open until August 26, 2025.

Motion made by Russell, seconded by Wahlert, to set a Hearing for Cash Transfers, Supplements and Contingency Transfers for July 17, 2025 at 9:30 a.m.

There were no county assistance/death expense applications.

Dar Coy, Emergency Manager, met with the Board.

Motion made by Cope, seconded by Allen, to approve and authorize the Chairman to sign the 3rd Quarter LEMPG Single Signature form.

He then provided updates and incidents, reminding the Board that the Emergency Plan is not a public document.

Lyle Norton, Sheriff, met with the Board.

Motion made by Wahlert, seconded by Russell, to approve and authorize the Sheriff and Chairman to sign the 2025 USDA/US Forest Service Contract.

Norton then presented the 2026 Budget request for the departments that he manages and to provide updates for the Sheriff's Department. He provided the jail census. There are 3 females and 9 males in house and 1 male in Meade County for a total of 13 inmates. He also distributed information regarding a potential system for incarcerated individuals to use for communication and educational purposes. He will bring it back to the next meeting.

Tony March, Highway Superintendent, met with the Board.

Motion made by Russell, seconded by Allen, to approve travel for Tony March to attend the 2025 SDACHS Workshop in Pierre on August 13, 2025 to include lodging and per diem.

Motion made by Cope, seconded by Russell, to approve the Application for Pipeline Easement from Mike Kindred in the area across Oak Tree Road at the intersection of Oak Tree Road and along Howl Road running south from Oak Tree Road approximately ½ mile and to approve the Application for Permit to Occupy County Right-of-Way from Renee Kindred along Howl Road from Oak Tree Road running south approximately ½ mile.

March presented the PI Worksheet from Brosz Engineering for material out of a ditch on Fall River Road AKA US Hwy 18 east of Hot Springs.

Motion made by Russell, seconded by Wahlert, to purchase off of Pennington County's Asphalt and Tack Oil bid.

March then provided Highway Department updates.

Steve Simunek, County Resident, met with the Board to discuss the damage to S Buffalo Gap Road and Oral Road by heavy equipment. March will look into what can be done to mitigate the issue.

The time being 9:30 a.m., the Sealed Bids for Land Lease of 240 acres more or less in SE1/4, Section 19, W1/2SW1/4, Section 20, in Township 8S, R3E, BHM, Fall River County, South Dakota.

Motion made by Allen, seconded by Russell, to approve the only bid of \$1,500.00, paid annually for the Land Lease Property.

Joe Allen, Commissioner, did not have anything to report on the proposed Jail/Justice Center, however, he stated that the County needs to get something started with an engineer for an evaluation of existing infrastructure versus a new build. He would like to get a professional to provide information to put into a referendum to be voted on by the citizens of Fall River County.

Motion made by Cope, seconded by Allen, to ask for quotes on a feasibility study for existing structures and/or new structures contingent on if the Building Fund monies can be used for this.

Stacey Martin, GIS Coordinator, met with the Board to discuss a request from the South Dakota Department of Revenue for GIS mapping. She will come back to the next meeting with a preliminary fee schedule if the County decides to sell the data. Martin then presented the 2026 GIS Budget request.

Sue Ganje, Auditor, met with the Board. She presented the award letter from the US Department of the Interior regarding P.I.L.T. money. Fall River County has received \$942,751.00.

Motion made by Allen, seconded by Wahlert, to set a Hearing regarding P.I.L.T monies distribution for Thursday, July 17, 2025 at 9:40 a.m.

Motion made by Allen, seconded by Russell, to approve the Change Order from Black Hills Exteriors to install roof vents on the Museum building at a cost of \$2,000.00.

Ganje did not present the Auditor and Election 2026 Budget requests. She will do them at a later date.

Lastly, Ganje asked what the Board would like to do with some of the surplus items in storage.

The Fall River Board of County Commissioners met in regular session on July 17, 2025. Present: Joe Allen, Les Cope, Joe Falkenburg, Deb Russell, Sandra Wahlert and Sue Ganje, Auditor.

An invocation was given by Wahlert.

The Pledge of Allegiance was given, and the meeting was called to order at 9:00 a.m.

The agenda was reviewed for conflicts; Commissioner Deb Russell noted a conflict in the appointment of a Veteran Service Officer and will recuse herself in all deliberations. No other conflicts were noted. ALL MOTIONS RECORDED IN THESE MINUTES WERE PASSED BY UNANIMOUS VOTE, UNLESS OTHERWISE STATED. The full context of the meeting can be found on the county website under Commissioners at http://fallriver.sdcounties.org or on Facebook on the Fall River County website.

Motion made by Russell, seconded by Wahlert, to approve the agenda with the addition of a motion to move the 2026 PILT money distribution hearing to the August 7th, 2025 agenda, and the addition to include a quote for from J.V. Bailey Co., Inc for the repair of the Oral Bridge, with possible action on both.

Motion made by Russell, seconded by Allen, to accept the Petition from the Paha Sapa Subdivision landowners requesting formation of the Paha Sapa Road District, and to set the meeting and election for August 19, 2025 at 5:00 p.m., located on first floor in the hallway of the Courthouse.

There were no County Assistance/Death Expense requests to present.

Quintin Riggins, Attorney with Gunderson, Palmer, Nelson & Ashmore, LLP, representing Don Fish, along with Jane Farrell, Farrell Law Firm, P.L.L.C., representing Kennedy Clay, LLC, and Joe Kennedy on the phone, met with the Board on the Fish Application to Establish a Right-of-Way to an Isolated Tract. A review of the application was given by Riggins, who asked to set a site visit. Farrell stated that this is not an isolated tract, noting a section line that has not been vacated, and access on the east side of the parcel. An engineer hired by Don Fish provided a map with areas marked of previously attempted right-of-way access. State's Attorney Russell spoke of his review of the petition, recommending the Board set the site visit with to include the Highway Superintendent to look at the section line. Discussion was held with commissioners, attorneys, and the applicant.

Motion made by Russell, seconded by Falkenburg, to set a site visit, as per SDCL 31-22-2 after the August 7th, 2025 Commission meeting, or the second meeting in August.

Dar Coy, Emergency Manager, met with the Board.

Motion made by Wahlert, seconded by Russell, to approve travel for Coy to attend Crisis Track Training July 29, 2025 in Pierre to include lodging and per diem.

Updates were given to the board on fires and incidents. Coy then turned the remainder of his time over to Black Hills Energy Vice President, Wes Ashton. Discussion was held with the Board on the BHE extreme weather (described as 45-55 mph winds and extremely low humidity) shut down policy in known

fire areas. Questions by the Board included the length of shutdown, when notifications would be given, the need for landowners to purchase generators and whether the shutdowns would be in metro areas such as Rapid City. Ashton spoke of tabletop exercises currently being held, and professionals within their staff. Ashton was questioned on the humidity factor, which BHE has not released that information at this time. Ashton also noted the BHE website would have information. The Chairman shut down the discussion for lack of answers to certain questions.

Coy spoke of working on shelter accommodations in the event of a shut-down, particularly for those with medical needs.

Lyle Norton, Sheriff, met with the Board.

Motion made by Allen, seconded by Wahlert, to authorize the Sheriff to sign contracts with Reliance Systems for inmate communication systems.

Complaint on your assessment may be made to your local Township or Municipal Board of Equalization by filing a written notice of appeal with the clerk of the local board of equalization no later than the Thursday preceding the third Monday in March. (postmarked by deadline is considered timely) The local board of equalization meets on the third Monday in March and is in session for five days. From the decision of your local board, you may appeal to your county board by filing a written notice of appeal with the county auditor on or before the first Tuesday in April. (postmarked by deadline is considered timely) County Board of Equalization meets on the second Tuesday in April and shall adjourn no later than three weeks after the second Tuesday in April. Appeal from your County Board may be taken to the State Office of Hearing Examiners. Such written notice must be filled with the Chief Administrative Hearing Officer 523 E. Capitol Ave Pierre, SD 57501, no later than the third Friday in May (postmarked by deadline is considered timely). Appeals to the Circuit Court may be taken from the county board or the Office of Hearing Examiners within thirty days from the publication of the decision. An appeal from the county board to circuit court will prevent an appeal to the Office of Hearing Examiner. However, you may appeal the decision of the Office of Hearings Examiner to circuit court.

Property tax relief programs are available for some property types in the State of South Dakota if the owners also meet eligibility requirements, which in some cases include financial criteria. Property that may be eligible for property tax relief include:

- (1) Property occupied by the owner, or a parent of the owner, or an adult child with a disability of the owner and classified as an owner-occupied single-family dwelling pursuant to SDCL 10-13-39 through 10-13-40;
- (2) Property owned and occupied by a veteran who is rated as permanently and totally disabled from a service-connected disability or the veteran's surviving spouse, pursuant to SDCL 10-4-40 and 10-4-41;
- (3) A dwelling specifically designed for use by a paraplegic as a wheelchair home that is owned and occupied by a paraplegic veteran, a veteran with the loss or loss of use of both lower extremities, or the veteran's surviving spouse, pursuant to SDCL 10-4-24.10;
- (4) A dwelling owned and occupied by a paraplegic or an individual with the loss or loss of use of both lower extremities, pursuant to SDCL 10-4-24.11;
- (5) Property owned by a citizen who reached 65 years of age or who is disabled, pursuant to SDCL chapter 10-6A.
- (6) The Municipal Property Tax Reduction is currently only available to Rapid City residents at this time.

Dear County Commissioners,

I am reaching out to urgently request your attention to a persistent and deeply frustrating issue affecting residents of my subdivision, Country Club Estates, in Hot Springs, SD 57747. For quite some time, we have endured consistently poor mail service, and despite repeated complaints to the local post office, there has been no meaningful resolution.

Mis-delivery of mail has become routine—residents frequently receive mail meant for others or fail to receive critical correspondence altogether. More recently, this issue has extended to packages, raising serious concerns about both convenience and the security of our personal property.

Each time this problem is reported, we receive the same response: that the postal carriers are new and lack experience, and that the issue is "being addressed." Yet after months of waiting patiently, there has been no visible progress, and the problem continues unabated.

Our community is beyond frustrated. Many of us rely on the postal service for medications, legal and financial documents, and other sensitive deliveries. This pattern of dysfunction not only erodes trust in public services, but also threatens residents' wellbeing.

We respectfully ask for your support in initiating oversight and investigating the underlying causes of these failures. The residents of Country Club Estates are entitled to reliable, professional mail delivery—something we have not had for far too long.

Thank you for your attention to this matter. We remain hopeful that with your involvement, this issue can finally be resolved.







An administrative hearing was held in the above matter on July 14, 2025, beginning at 1:00 p.m. CT. Hearing was held in Pierre South Dakota at the Capitol. Petitioner, Kenneth & Alicia Feist appeared at the hearing. Fall River County State's Attorney Lance Russell represented Fall River County. Appearing as witnesses at the hearing was Lillian Heidebrink, a Director of Equalization for Fall River County.

ISSUES

Whether the subject property was assessed higher than market value and/or is assessed higher than comparable property? Both parties agree that only the land value is at issue in this case. No structure values are at issue in this case.

FINDINGS OF FACT

- 1. The Legal Description of the property is Feist Tract, Sec 22, TWP 7, RG 5.
- 2. Feist, Kenneth & Alicia Feist Revocable Trust owns the single-family, owner-occupied residence located at 12765 Pine Haven Rd, Hot Springs, SD 57747.
- 3. The highest and best use is that of a single-family residence. It is a single-family residence built on a 5.06-acre lot.
- 4. The house, built in 2022, is a 3,630 square foot, single-story residence.
- 5. Petitioners are only raising the issue of the land evaluation. Petitioners are not raising the issue of the structure value.
- 6. The Office of Equalization visited the home site on November 7, 2022.
- 7. The most recent appraisal of the subject property was done in 2025 by the County. It was appraised at \$833,940; \$115,360 for the land and \$718,580 for the house. Petitioner appealed this to the Local Equalization Board, which affirmed the evaluation. This was then before the County Equalization Board, which affirmed the evaluation.

- 8. Petitioner timely appealed the appraisal to the County Board of Equalization. Petitioner's argument is that the subject property should be appraised in the same manner as the land in the nearest development, Pine Haven Subdivision.
- 9. The Office of Equalization used both the Cost and Sales approach when valuing the property. The property is not an income producing property; therefore, the income approach was not considered.
- 10. The Cost approach factors in depreciation based upon the age and maintenance of the house, as well as depreciation for obsolescence, based upon the location of the house. The County used the Vanguard appraisal tool for valuing the house and outbuildings.
- 11. The Director also utilized the Sales Approach when valuing the property. The Director presented comparable sales of bare land properties within that district, in the neighboring section 21, and the final sales prices. Property one has an address of 27427 Nickel Drive (20.102 and 4.687 acres), it sold for \$182,000 in September of 2024. Property two has an address on Whitetail Road (14 acres), it sold for \$342,500 in January of 2024. Property three is also in Section 21 (32.37 acres), it sold \$269,900 in December of 2023. There was one sale outside Section 21 or 22 and still within the District, in Section 14 on Hot Brook Canyon Road (.86 acres) which sold in January 2024 for \$57,000.
- 12. County values the property in the Northwest District by using a tiered acre system. The First Acre is valued at \$60,000, Acres 2-5 are valued at \$10,000 each, Acres 6-10 are valued at \$6,000 each, Acres 11-20 are valued at \$4,000, Acres 21-40 are valued at \$2,000 each, and Acres 41-80+ are valued at \$1000 each.
- 13. All comparable properties presented by the County were bare land residential lots on a rocky, partially treed slope.
- 14. The sales prices for the bare land properties that are in the same district confirm that the assessment by the County is correct. The tiered valuation for the land is the amount that a willing buyer would pay for a similar bare lot in that area.
- 15. Any additional findings included in the Reasoning section of this decision are incorporated herein by this reference.
- 16. To the extent any of the findings of fact are improperly designated and are instead conclusions of law, they are hereby redesignated and incorporated herein as conclusions of law.

REASONING

All real property in South Dakota is subject to taxation, unless expressly excepted. SDCL 10-4-1. Taxes on real property are based on value. SDCL 10-6-119 provides that property be assessed at its true and full value. SDCL 10-6-119 provides as follows:

The director shall individually assess each tract of real property at its fair market value. In determining the fair market value of property, the director may not adopt a lower or different standard of value because it is to serve as a basis of taxation. The director may not adopt as a criterion of value the price for which a tract of real property would sell at a forced sale, or in the aggregate with all other tracts of real property in the county. The director shall determine the fair market value by appropriate consideration of the cost approach, the market approach, and the income approach to appraisal. The director shall consider and document all elements of such approaches that are applicable prior to a determination of fair market value.

The Courts have said, "Simply asserting that the valuation was in excess of the true and full value does not make it so.... Taxpayer must demonstrate that the tax assessment was unjust and inequitable." *Richter Enterprises Inc. v. Sully County*, 1997 S.D. 61, ¶14, 563 N.W.2d 841, 845. The Supreme Court clarified the burden of proof in county equalization cases:

We have previously stated that taxation disputes incorporate a presumption that tax officials act in accordance with the law and the taxpayer bears the burden to overcome the presumption. Taxpayers meet their burden to overcome this presumption by producing sufficient evidence to show the assessed valuation was in excess of true and full value, lacked uniformity in the same class, or was discriminatory.

Trask v. Meade Cnty. Comm'n, 2020 S.D. 25, ¶36 (internal quotes, citations, and footnote omitted).

"The assessment of real property in South Dakota at its true and full value is both constitutionally and statutorily mandated. *Pirmantgen v. Roberts Cty.*, 2021 S.D. 5, ¶ 23, 954 N.W.2d 718, 725. The director of equalization is commanded to appraise property *each year*. *Id*. These taxes are also constitutionally required to be uniform and never to exceed the actual value thereof. *Id*.

The Director of Equalization gave testimony at the hearing, explaining how each piece of property in the County is assessed. The Fall River County Director of Equalization provided evidence and testimony that the County is broken into different appraisal districts based on land types. The Director of Equalization only compares properties to those based in the same district. This is because land in different locations sells differently and thus has different values. The subject property is in the Northwest area. Furthermore, every property with a homesite is assessed \$15,000 for having a homesite.

The County entered the tiered land value table for the Northwest area into evidence. This table explains that the first acre is appraised at \$60,000. The next 4 acres are appraised at \$10,000 per acre. Finally, the next five acres are appraised at \$6,000 per acre, with this tier phasing out at 10 total acres. The higher levels of this table are listed in the Findings of Fact. Using this table ensures the properties are assessed in a uniform manner with other similar properties.

The land at issue here is 5.06 acres in size. Using the applicable tiered land table for the subject property, the first acre is \$60,000. the next four acres is assessed for \$40,000 and the six hundredths of an acre is assessed at \$360. Finally, \$15,000 is added to the land value since it is a home site. This brings the total land value to \$115,360.

The Petitioner raised the issue that this evaluation was not comparable to other properties in the Northwest District due to size and location. He testified that it should be compared to and appraised similarly to the properties in the Pine Haven Subdivision that have a lower land value. The Director of Equalization provided testimony at the hearing about how the subject property and the Pine Haven Subdivision properties are distinct. They are distinct because properties in the subdivision have restrictions, while the subject property does not have such restrictions. The Director of Equalization also provided testimony that Fall River County does not have zoning, and the subject property is free from restrictions, whereas the Pine Haven Subdivision properties are subject to restrictions.

The Northwest District properties consist of properties developed by homeowners and not located within a traditional development with similarly built homes. Many homes in the Northwest lie alongside ag land or ranch land and it is bordered by or very near the Black Hills National Forest, such as Petitioner's. The testimony and evidence provided does not lead to the conclusion that the subject property was put into an incorrect district or development for tax assessment purposes. The Pine Haven Subdivision properties are not similarly situated to the subject property.

The counties are legally required to keep the median property values in the county at least 85 percent of the market rate. SDCL 10-3-41. The median property values must be at eighty-five percent and not more than one-hundred percent. SDCL 10-6-121. The County found that the sales ratio for the properties in the Northwest District were selling at a higher rate than the appraisals; the sales ratio was in the mid-60s. That required the County to raise the appraisals in that area. The properties in Pine Haven Development were not selling higher than the appraisals and so the County value the Pine Haven land differently.

CONCLUSIONS OF LAW

- 1. The Office of Hearing Examiners has jurisdiction over the parties and the subject matter of this appeal pursuant to the provisions of SDCL 1-26D, 10-10-11 and 10-11-42.
- 2. SDCL 10-3-16. "The director of equalization shall assess for taxation all property subject to taxation, except property which the secretary of revenue has been directed to assess, which is situated in the county or municipality for which the director is appointed, including all property located within the corporate limits of each municipality.
- 3. Fall River County assessed the property based upon the Cost Approach using the Vanguard cost tool. The County confirmed the value by utilizing the Sales Comparison Approach. The Income Approach does not apply to this property.

- 4. The County has met their burden to show that the property is assessed for full and true value; the value is more than 85% and less than 100% of the market value. SDCL §10-6-121. The County classification of the subject property to the Northwest District is not improper. The County is required to assess the property based upon its location within the county. SDCL §10-5-1. The evidence supports the County decision to classify the subject property in the Northwest District as opposed to the Pine Haven Subdivision.
- 5. The County acted in accordance with the law in valuing the subject property
- 6. County's assessed full and true value of the property is \$833,940; \$115,360 for the land and \$718,580 for the improvements.
- 7. Petitioner has not shown that the assessed value is in excess of true and full value, lacks uniformity in the same class, or is discriminatory. Petitioner has not met their burden.
- 8. Any additional conclusions of law included in the Reasoning section of this decision are incorporated herein by this reference.
- 9. Any Conclusions of Law in the reasoning section of this decision are incorporated herein by reference. To the extent any of the foregoing are improperly designated and are instead findings of fact, they are hereby redesignated and incorporated herein as findings of fact.

ORDER

It is the Order of the Hearing Examiner that the assessment of the County in this manner was not in excess of true and full value. The valuation of the subject property by the County was appraised in a uniform and equalized manner throughout the district in which the property is properly classified and located. The Petitioner's subject property at issue in this hearing is assessed at \$115,360 for the land and \$718,580 for the improvements.
