**CONTRACT FOR HOUSING OF PRISONERS AND DETAINEES
IN THE PENNINGTON COUNTY JAIL**

Comes now, the Pennington County Sheriff (PCSO), located at 300 Kansas City Street in Rapid City, South Dakota and the Fall River County Sheriff (FRCSO), located at 906 N. River Street in Hot Springs, South Dakota, and agree as follows:

WHEREAS, PCSO manages and operates the Pennington County Jail located at 307 Saint Joseph Street in Rapid City, South Dakota used for housing of prisoners and detainees and that FRCSO does not have adequate facilities in Fall River County (FRC) for the housing of prisoners and detainees, and

WHEREAS, PCSO is willing to enter an agreement with FRCSO for the housing of prisoners and detainees from FRC under the terms and conditions set forth herein.

ACCORDINGLY, the parties stipulate and agree as follow:

1. PCSO agrees to house and take care of prisoners and detainees of FRC, provide food, clothing, bedding, shoes, hygiene supplies, and other items provided to Pennington County (PC) prisoners on a daily basis. Supervision will be provided by PCSO or its designee in accordance with the written document known as the PC Jail Policies and Procedures Manual. In return for said services being performed by PCSO, FRCSO agrees to pay PCSO [\$110] per day for each inmate day. Inmates identified by PCSO as special management due to behavioral, medical, or mental health issues that utilize more resources will be billed at [\$130] per day for each inmate day. PCSO will communicate with FRCSO prior to charging the increased rate. PCSO will bill for the day of arrival but not for the day of departure.
2. FRCSO herein agrees and understands that it is their responsibility to transport prisoners to the PC Jail at their expense and to provide transportation for prisoners to and from Court at the expense of FRCSO. FRCSO further agrees and understands that it is the responsibility of FRCSO to know when prisoners of FRC are to be in Court. FRCSO also agrees that PCSO does not routinely provide transportation for inmates to Court, Video Court, or medical facilities. FRCSO herein agrees and understands that if transportation is requested by FRCSO and agreed to by PCSO, PCSO will bill transportation costs to FRCSO at [\$0.70] per mile and [\$40.00] per hour for one deputy/guard and an additional [\$40.00] per hour for any additional deputy/guard, as deemed necessary by PCSO. Transportation costs include moving


prisoners to video court within the PC Jail. All transport costs have a minimum fee of one hour, with billing occurring in 1/4-hour increments after the first hour.

3. FRC SO herein agrees and understands that PCSO will, when necessary, provide extraordinary and emergency medical or dental care for prisoners or detainees of FRC, that FRC SO will pay the entire expense associated with said extraordinary and emergency medical or dental care; including transportation to and from medical or dental facilities, hospital expenses, drug expenses, doctor expenses, guard fees and any other necessary and proper expenses born by PCSO in connection with extraordinary and emergency medical and dental care. FRC SO herein further agrees and understands that the determination as to whether or not medical or dental care is an emergency will be left to the discretion of the PCSO or his designee. If extraordinary care is indicated, the PCSO will consult with FRC SO to determine proper and reasonable medical care for which FRC SO will be financially responsible.
4. FRC SO herein agrees and understands that PCSO will bill FRC SO for prisoners and detainees held by PCSO for FRC SO. Said bill shall include the cost of each day's housing or lodging at the rate of [\$110] per day and any and all medical, mental health, dental or physician care incurred by PCSO. FRC SO agrees to reimburse PCSO on a monthly basis for all bills submitted by PCSO.
5. FRC SO herein agrees and understands that all prisoners and detainees of FRC housed in the PC Jail are subject to supervision provided by the PCSO or his designee in accordance with the written documentation known as the PC Jail Policies and Procedures Manual and any and all State standards that may be forthcoming by the South Dakota legislature or other authorized committee or agency of the State of South Dakota.
6. FRC SO agrees to hold harmless and indemnify PC, PCSO and its officers, agents and employees, from and against any and all claims, actions, suits, damages, liability, judgments or other proceedings, including attorney fees and court costs, which may arise as a result of FRC prisoners and detainees being housed in the PC Jail and receiving medical or dental care and transportation services, all as contemplated and authorized in this Agreement. This section does not require FRC SO to hold harmless and indemnify PC, PCSO and its officers, agents and employees from claims or liability arising solely from the acts or omissions of PCSO, its officers, agents and employees.
7. The parties to this agreement herein fully agree and understand that PCSO may cancel this agreement by giving thirty (30) days written notice to the FRC SO. Said notice shall be sent by certified or registered mail. FRC SO herein agrees and understands it shall have no claim or claims of any kind against PC or the PCSO for cancellation of this agreement. FRC SO further agrees and understands that should

PCSO wish to alter any terms or conditions of this agreement, including the cost of housing prisoners, that said alterations or changes shall be provided in writing to the FRCSO by certified mail and FRCSO herein agrees and understands that said alterations or changes shall commence and take full force and effect thirty (30) days after notice of the same is received by FRCSO.


8. The parties to this agreement specifically agree and understand that any and all changes in this agreement shall be made in writing and attached to the master copy of this agreement which shall be held by PCSO. The parties to this agreement do further agree and understand that this agreement constitutes the complete understanding and agreement of the parties hereto and that no other oral agreements have been made that are binding upon the parties hereto.
9. FRCSO herein agrees to provide copies of the authority to PCSO to hold a prisoner or detainee. The authority to hold shall be either an Order of the Court, Warrant of Arrest and/or Complaint, Bench Warrant, Traffic Citation, Sentence, together with the signature of the officer delivering said prisoner or detainee on a form entitled Custody Authorization Form. PCSO reserves the right to reject any prisoner or detainee delivered without adequate authorization. Said paperwork is the consent of FRCSO for PCSO to bill FRCSO under the terms and conditions of this agreement or future addendum or modification of this contract.
10. FRCSO hereby acknowledges that PC is the owner of the PC Jail and that the operation and management of said Jail is vested in PCSO. Any rights, terms or condition provided for in the PC Jail as part of this agreement vests in, and is subject to, the ultimate control of PCSO.
11. Effective Date/Term of this Agreement is January 01, 2026 thru December 31, 2026.

89 Distress Warrants for delinquent taxes on mobile homes or buildings on leased sites have been forwarded to the Fall River County Sheriff's Office for collection, totaling approximately **\$32,433.55**.

SDCL § 10-22-8. Distress warrant against person for delinquent mobile home taxes or taxes on building on leased site.

The treasurer may issue a distress warrant against any person whose mobile home taxes or taxes on a building on a leased site are delinquent at any time. The treasurer shall issue a distress warrant against any person whose mobile home taxes or taxes on a building on a leased site are delinquent when requested by any county commissioner or sheriff of the county.

Commissioners – Please be advised I have checked the South Dakota Legislative Audit's website and found all the banks the County is currently doing business with have all pledged the proper amount of collateral. These reports are updated quarterly and should any bank fall below the collateralized amount according to law. Fall River County will cease to do business with them until which time they meet the necessary requirements by South Dakota Law. This is in accordance with SDCL § 4-6A-3.

SDCL § 4-6A-3. Segregation of collateral by public depository--Value--Deposit and designation--Letters of credit and surety bonds.

Every qualified public depository shall at all times maintain, segregated from its other assets, eligible collateral having a value at least equal to its maximum liability under this chapter. Such collateral shall be segregated by deposit in such manner as the commission approves. The collateral shall be clearly designated as security for the benefit of public depositors under this chapter and shall be pledged as collateral for those public deposit accounts which exceed deposit insurance. Irrevocable standby letters of credit or surety bonds shall be segregated or issued in such manner as the commission approves.

I would like to report to you that I am currently working on **50** tax certificates involving properties with delinquent real property taxes that are more than three years past the certificate date, representing the 2021 assessment year payable in 2022 and prior years. The breakdown includes Edgemont (17), Oelrichs (3), Hot Springs (22), and properties in the County (8).

Of the 50 certificates, 4 properties have recently been taken by tax deed, with an additional 3 expected to be completed by February 2026.

The approximate total amount owed for delinquent taxes, interest, and associated fees related to these certificates is \$299,674.00.

I am also working with approximately 10 property owners who have tax certificates on their properties to allow them to bring their taxes current before tax deed proceedings begin and before additional fees are incurred once the tax deed proceedings start.

My goal is to resolve the remaining tax certificates in 2026 which will allow the office to shift its focus toward proactive collection practices.

COMBINED ELECTION AGREEMENT

This agreement is entered into between Fall River County, the City of Hot Springs, the Hot Springs School District 23-2, the Town of Oelrichs and the Oelrichs School District 23-3; all political subdivisions of the State of South Dakota, for the purpose of conducting a combined election provided under the provisions of SDCL 9-13-37, 13-7-10.3, 12-2-5 and 12-2-6 and allocating expenses of combined elections including elections to which the county is not typically involved.

EFFECTIVE DATE: This agreement shall become effective on the date that all parties have signed the agreement.

COMBINED ELECTIONS:

Cost Share: Invoices will be issued by the County to each of the other parties upon completion of the election process after expenses have been divided appropriately.

- Each entity shall publish its own required notice of vacancy, other notices will be jointly published. The cost of jointly published notices shall be shared equally, except for the cost of publishing the sample ballot, where the cost shall be shared proportionately by ballot issue and/or candidate.
- Salaries and expenses of shared polling places will be shared proportionately by ballot issue and/or candidate by all the entities. The County is responsible for finding Poll Workers.
- The cost of materials (ballots, absentee envelopes, etc.) will be shared proportionately by ballot issue and/or candidate. Each entity will pay the cost of its individually used materials and supplies.
- Programming costs (ballots, Expressvotes, software, scanner, etc..) shall be shared proportionately by ballot issue and/or candidate.
- If any entity in the agreement is not required to have an election, the only cost to be paid by the entity/entities will be the Notice of Vacancy publication.

Fall River County will pay all costs associated with the election and the other parties agree to reimburse the County for each of their shares of the costs as determined in this agreement.

Proportionately is described as, the percentage of space used on the ballot for each entity's ballot issues and/or candidates and will be agreed upon by each entity for each election.

Absentee/Early Voting: Absentee ballots shall be available at the Fall River County Auditor's Office for voters who wish to vote absentee/early. Absentee board(s) will be hired by Fall River County and payment for the workers shall be shared equally between entities participating in the election.

Election Night Counting Board: If the City of Hot Springs, the Hot Springs School District 23-2, the Town of Oelrichs and/or the Oelrichs School District 23-3 place an item on a June Primary or November General Election ballot, those entities each agree, at no cost to the county, to provide a minimum of one (1) worker, if requested by the county, to assist in some capacity on election day.

Canvassing the Vote: Each entity shall canvass the votes of their election at the next designated meeting following the election. Poll books will be opened by the Fall River County canvassing board, canvassed, resealed and passed on to the next entity who will follow the same process until all entities have completed their canvassing process.

Other elections in which Fall River County is not a participant:

Cost Share: Fall River County is not responsible for supplying other entities with supplies (absentee envelopes, etc.) needed to hold their own elections. However, if Fall River County provides supplies, in emergency situations, the County will be refunded the cost of the supplies that were used.

All costs incurred by Fall River County during election shall be invoiced back to the City/Schools/Town. Payments for said costs shall be remitted thirty (30) days after receipt of said invoice from Fall River County.

Equipment: Fall River County agrees to supply voting booths, secrecy sleeves and the required signage at no cost. The entity holding the election is responsible for setting a time and assisting with getting that equipment ready for Election Day and scheduling a time to assist in the return of said items. The entity is also responsible for transport and setup/teardown of the equipment. They are also responsible for the costs of replacing missing equipment and repairing any damage, other than mechanical failure. Other entities may choose to utilize the DS450 (automatic tabulating machine) at a cost of \$300.00 plus the cost of the County Election employees' salaries for their time to assist with the machine.

Election Support: Fall River Auditor's office staff will be present in the Auditor's office from 7:00 a.m. to 7:00 p.m. on Election Day to assist with registration issues and questions. The County will equally invoice each entity involved, the cost of the overtime pay incurred for the staff.

Other: At any time Fall River County, the City of Hot Springs, the Hot Springs School District 23-2, the Town of Oelrichs and/or the Oelrichs School District 23-3 may request to revisit this agreement to make any needed changes or updates.
