Motion made by Russell, seconded by Allen, to approve a wage increase for Isnalawica Belt longevity to go from \$25.00/month to \$50.00/month for 5 years of service, effective 11/3/2025.

Motion made by Wahlert, seconded by Russell, to approve the hire of Carlee Weishaupl as a part time Custodian at \$16.00/hr, effective 10/27/2025.

There were no county assistance/death expense applications.

Dar Coy, Emergency Manager, met with the Board, to request travel approval and to give an update regarding the flu shots which were located at the Mueller Center, with 38 administered shots for free, which is 3 times more than last year.

Motion made by Russell, seconded by Wahlert, to approve travel for Dar Coy, Emergency Management, to attend the Safety Benefits training in Pierre on November 12th & 13th, 2025, to include lodging & per diem.

Lyle Norton, Sheriff, met with the Board to present an agreement and to provide updates.

Motion made by Cope, seconded by Wahlert, to approve the 2026 Law Enforcement Agreement between Fall River County and City of Edgemon, and authorize the Sheriff to sign.

Motion made by Russell, seconded by Allen to purchase a Law Enforcement vehicle off State Bid. With Cope saying no, all others voting yes, the motion carried.

Motion made by Allen, seconded by Wahlert, to approve hire of Shea Zeller as an Uncertified Deputy Sheriff at \$22.50/hr., effective 11/03/2025.

Norton then provided the jail census. There are 2 males and 3 females in house with 1 male in Meade County for a total of 6 inmates.

Deb Russell, County Commissioner, met with the Board to present a report on the security meeting.

Motion made by Russell, seconded by Allen, to accept an estimated cost from JD Cast for 4 concrete moveable barriers 10' length x 32" height to use by the propane tank at \$455.00 plus 2 concrete movable barriers for the front of the courthouse. Also, delivery charge of \$4.00 per loaded mile. An invoice will be presented at the next meeting. There will be 75% reimbursement from the Unified Judicial System.
