All motions unanimous unless otherwise stated. Motion to approve the agenda ,minutes of the last meeting, budget review for January and February 2025 was made by Joe Falkenburg and seconded by, Bob Novotny . The board is being asked to submit information for updating pay. Board members are in agreement to be paid once at the end of November.
